



Did then and there commit the following offense and the facts supporting this belief are as follows:

The City of Columbia received complaints about Tiger Barbershop not being in compliance with the mask ordinance on October 22, October 28, November 6 and November 17, 2020. Copies of those complaints are attached.

I visited the business on the afternoon of Tuesday, November 3, 2020 and observed one employee not wearing a mask while providing service to a customer within 6 feet.

I visited Tiger Barbershop again at approximately 1:15 p.m. on Wednesday, November 18. When I entered there were two employees working and neither wore a mask. Both were within 6' of the customer. One employee was finishing with a customer who was wearing a mask; the other barber was cutting the hair of a customer who was not wearing a mask. I spoke to a barber and told him that I was visiting to share two more mask complaints. He said he was not wearing a mask due a health exemption. I asked him about the other employee and he said that person also had a health exemption. He shared no detail about the exemptions. He also shared with me that there had been MU students entering his business taking pictures to document that they were not wearing masks and were reporting those to the City.

That these facts herein are true and constitute a violation of Emergency Ordinance 024285, Section _____ of the Columbia Code of Ordinances and punishable under Ordinance 024285 Section 9 of the Columbia Code of Ordinances.
