I am writing to confirm we have received your request to speak at the July 17th City Council meeting. However, it is our policy that scheduled public comments not be allowed on any topic related to an agenda item under public hearing, old business, consent agenda, new business or introduction and first reading. There will be a bill (B198-17) on the old business section of the agenda that relates to your topic.

Since items on old business allow for public comment already, we cannot allow a scheduled public comment. You will just want to approach the dais to address Council when this item comes up and the Mayor opens the item up for public comments. You will still be allowed the same time limits of 3 minutes as an individual and 5 minutes if you represent a group.
