

PETITION REQUESTING ANNEXATION TO THE CITY OF COLUMBIA

1. Margret Anne Andrews, ETAL is the owner of all fee interests of record in the real estate in Boone County, Missouri, described as follows:

A TRACT OF LAND LOCATED IN THE SOUTHEAST QUARTER OF SECTION 19 AND THE WEST HALF OF THE SOUTHWEST QUARTER OF SECTION 20, ALL OF TOWNSHIP 48 NORTH, RANGE 13 WEST, BOONE COUNTY, MISSOURI AND BEING DESCRIBED BY THE WARRANTY DEED RECORDED IN BOOK 2633, PAGE 131 AND FURTHER BEING ALL OF TRACT B OF THE SURVEY RECORDED IN BOOK 383, PAGE 960 LYING NORTH OF THE COUNTY ROAD AND EXCEPTING THEREOF THE 17 ACRE TRACT SHOWN IN THE SURVEY RECORDED IN BOOK 2389, PAGE 9, AND CONTAINING APPROXIMATELY 37 ACRES MORE OR LESS.

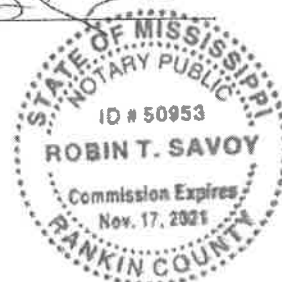

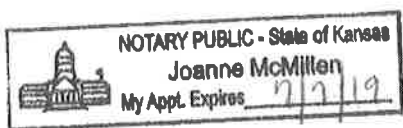
