As the owner of the largest commercial property impacted by these access changes, we have some serious concerns over the loss of a full access drive and how that changes the valve of the property. We are meeting with our tenants for additional feedback, but here are our initial thoughts:

- 1. The right in, right-out only option is a non-starter and will drive out all of our tenants. The only option we might consider is ¾ access.
- 2. In the event we can make ¾ access work, we would need the City to give us a access easement through the private drive to our west in order to utilize the new signal.
- 3. It would be good to straighten the intersection of Monteray and the private drive to the west.

- 4. A good plan to replace our lost access would include a right-in, right-out form the Providence outer road to Providence similar to Hy-Vee across the street.
- 5. It would be good to see sidewalks added to the Providence outer road on the east side of our property for full connectivity.

I will also note that our direct competitor Breaktime is being given two left hand turn opportunities to their facility.
