A RESOLUTION

authorizing the temporary closure of portions of sidewalks and streets along Paquin Street, Hitt Street and University Avenue to facilitate the construction of a building located at 1101 University Avenue.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes the following temporary sidewalk and street closures requested by the University of Missouri, as shown on "Exhibit A" attached hereto, to facilitate the construction of a building located at 1101 University Avenue:

- 1. Sidewalk closure along the south side of Paquin Street between Matthews Street and Hitt Street from January 10, 2018 through August 3, 2018.
- 2. Closure of the eastbound lane of University Avenue between Matthews Street to the intersection of Hitt Street from March 23, 2018 through April 27, 2018.
- 3. Closure of the intersection of University Avenue and Hitt Street from May 14, 2018 through June 1, 2018.
- 4. Closure of Hitt Street from University Avenue to the south entrance of the Hitt Street municipal parking structure and closure of the eastbound lane of University Avenue from the intersection of Hitt Street to a point 60-feet east of the intersection from May 14, 2018 through June 22, 2018.
- 5. Closure of the westbound lane of University Avenue from the intersection of Hitt Street to approximately 60-feet east of the intersection from June 22, 2018 through July 6, 2018.

SECTION 2. The University of Missouri shall close those portions of the sidewalks and streets only in accordance with the closure plan submitted and approved by the City's Director of Public Works. In the interest of public safety, the Director of Public Works may require additional traffic control measures by notifying the University of Missouri, in writing, of such requirements. The University of Missouri shall be responsible for all signs and barricades necessary for the protection and convenience of the general public and shall be responsible for the repair of the sidewalks and streets due to any damage caused by the construction activity. The University of Missouri shall be responsible for notifications to the media and emergency personnel.

SECTION 3. The University of Missouri shall proceed with construction activities which require the sidewalk and street closures without unnecessary delay so as to minimize disruption to the public. Failure to proceed without unnecessary delay may result in the revocation of the closure permit by the City Council.

SECTION 4. The temporary sidewalk and street closures authorized herein may be terminated by the City Council upon recommendation of the Director of Public Works and a determination such closures are no longer necessary for the protection of the health, safety and welfare of the public or is otherwise in the best interest of the public.
