Ordinance No. 023160 Council Bill No. B 105-17

### AN ORDINANCE

amending Ordinance No. 023001 to authorize permit holder and certifier registration designations and the electronic filing of discharge monitoring reports with the Missouri Department of Natural Resources Water Protection Program; and fixing the time when this ordinance shall become effective.

WHEREAS, Ordinance No. 023001, passed on November 21, 2016, authorized the City Manager, or the Manager's designee, to execute and submit an Electronic Discharge Monitoring (eDMR) Permit Holder and Certifier Registration with the Missouri Department of Natural Resources Water Protection Program for the Columbia Regional Wastewater Treatment Plant; and

WHEREAS, Ordinance No. 023001 also authorized the Utilities Director, or the Director's appointed designee, to prepare and file electronic discharge monitoring reports (eDMRs) with the Missouri Department of Natural Resources Water Protection Program; and

WHEREAS, since passage of Ordinance No. 023001, the City received notification that electronic discharge monitoring reports (eDMRs) are required for all National Pollutant Discharge Elimination System (NPDES) permits issued to the City of Columbia, Missouri; and

WHEREAS, it is necessary to revise Ordinance No. 023001 to update the Electronic Discharge Monitoring (eDMR) Permit Holder and Certifier Registration to include other applicable departments within the City of Columbia, Missouri issued NPDES permits, as well as expanding the authorization to prepare and file electronic discharge monitoring reports with the Missouri Department of Natural Resources Water Protection Program to such department directors.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Section 1. of Ordinance No. 023001 is amended as follows:

SECTION 1. The City Manager, or the Manager's designee, is authorized to execute and submit an eDMR Permit Holder and Certifier Registration, and provide any other required information or execute such other agreements associated therewith, as requested, with the Missouri Department of Natural Resources Water Protection Program as it relates to the electronic filing of discharge monitoring reports for the City of Columbia, Missouri ~~Columbia Regional Wastewater Treatment Plant~~.

SECTION 2. Section 2. of Ordinance No. 023001 is amended as follows:

SECTION 2. The Directors, or the Directors' appointed designee, of those departments within the City of Columbia, Missouri issued National Pollutant Discharge Elimination System (NPDES) permits are ~~The Utilities Director, or the Director's appointed designee,~~ is authorized to prepare and file electronic discharge monitoring reports (eDMRs) with the Missouri Department of Natural Resources Water Protection Program in compliance with the National Pollutant Discharge Elimination System (NPDES) Electronic Reporting (eReporting) Rule [80 FR 64063], and execute such agreements or affirmations as may be required to electronically file such reports.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
