IV. NEW BUSINESS

A. IPMC Section 702.4.1 Emergency Escape

Mr. Shanker expressed concern that the owners of existing dwelling units that have non-compliant bedrooms in the basement would be prohibited from using those bedrooms by registering the dwelling unit with neighborhood services as a rental.

Mr. Shanker believes this would create safety concerns because owners will resist registering the dwelling and the basement bedrooms will be used without adding the smoke detection as allowed in the Amendment to Section 702.4.1. Mr. Shanker does not believe it makes sense to use the January 1, 1993 date as a deadline for being in the system.

City Staff explained that the Jan 1, 1993 date became the deadline during the review of the 1993 National Property Maintenance Code (BOCA). This Code required the emergency escape access in existing sleeping units. The Amendment was created so those already in the system could continue with additional protection.

After much discussion, the topic was tabled until the next meeting, May 22, 2017.

B. Introduction of new board members

Brian Connell introduced Drew Wallace. The Committee also welcomed John Neyens and Austin Tipton. Each member spoke briefly about experience and qualifications.

JP Watson was introduced as a potential candidate to fill the engineer position vacated by Andrzej Bernacik.

V. OLD BUSINESS

Trade Licensing Ordinance Amendments to align all three trade license

The BCCC reviewed changes to current Trade Ordinances to more closely align all three Trades per staff recommendation.

Proposed revisions to Trade Ordinances:

1. Penalty fees associated with late renewal removed from the Plumbing Ordinance to match the Electrical and Mechanical.

2. Reciprocity (Section 101.8.2) added to Mechanical Ordinance.

3. Expiration and revocation sections added to the Electrical (304.15) and Mechanical (101.8.3) Ordinances to match the Plumbing Ordinance.

The Board agreed all in favor, except Richard Shanker, to the proposed revisions.

Additionally, Staff sought opinion of the BCCC regarding the intent of Trade Ordinances to require a Master tradesperson to be a part of the Business License requirements for approval.

John Simon stated he would ask the City Legal Department to draft a proposed ordinance for discussion.
