**AGREEMENT**

This agreement is entered into on this \_\_\_\_\_ day of \_\_\_\_\_, 2007, between the City of Columbia, Missouri, a municipal corporation, (hereinafter "City") and J.W. Broadcasting, LLC (KMIZ-TV), (hereinafter "Contractor").

City and the Contractor agree as follows:

1. Contractor shall provide a public, non-profit 4th of July, 2007 public fireworks display on University of Missouri property leased by the City of Columbia for an Independence Day celebration.
2. Upon execution of this agreement, City shall pay Contractor Five Thousand Dollars (\$5,000) to pay part of the cost of the public fireworks display.

**Summary:** Staff has prepared for Council consideration a resolution authorizing an agreement with J. W. Broadcasting, LLC (KMIZ-TV) to assist with funding of the fireworks display for the community's Fourth of July Celebration. The agreement authorizes the transfer of \$5,000 to be applied to the cost of the public fireworks display.

**Discussion:** The City's FY 07 budget includes \$5,000 to assist with the purchase of fireworks for the annual Fourth of July "Fire In The Sky" Celebration. This agreement sets forth the transfer of these funds to J.W. Broadcasting, LLC/ KMIZ TV who has contracted for the fireworks display. The funds will be used exclusively for the cost of the public fireworks display and will supplement other funds raised by KMIZ to cover the cost of the display.

Other Info.

KMIZ-TV has taken over the coordination of and fundraising for the July 4 event, including the fireworks display, for this year. The City has assisted with funding of the fireworks display for many years. The Parks and Recreation Department will continue to assist in the programming of the event. This year's celebration will again be held on University of Missouri property and spectators will be allowed into Memorial Stadium to view the display.
