1. The total not-to-exceed contract amount is hereby increased by \$1,998.00 from \$259,239.00 to \$261,237.00 to increase funding due to increased caseload, effective for the period October 1, 2006 through September 30, 2007.
2. Annual caseload is increased by 216 from 25,128 to 25,344.

SUMMARY

A resolution authorizing the City Manager to sign Amendment # 4 to Local Agency Nutrition Services Contract #ERS045-6219 to allow a one time increase in funding for September 2007 WIC billing. This amendment is in the amount of \$1,998.00.

NARRATIVE

The Health Department has been awarded this small increase in funding because the WIC caseload has exceeded the FY 2007 approved caseload for the last quarter.

FISCAL NOTE

This additional revenue does not necessitate an appropriation because it can only be applied to personnel costs.
