RE: Permanent Park Improvement Fund Transfers

EXECUTIVE SUMMARY:

The Columbia Parks and Recreation Department has received several donations and/or funding assistance to help support various recreation programs. These include: Sam's Club (\$1,000) for the Blue Thunder Track Program; Toys for Columbia's Youth (\$358 from various donors); Perlow-Stevens Gallery (\$78) for the CARE Gallery; and Missouri Arts Council (\$5,428) for the CARE Gallery. This Ordinance accepts the contributions and appropriates the funds to the proper account for expenditure during FY 08.

DISCUSSION:

The Parks and Recreation Department has received several donations and /or funding assistance in support of various programs it offers.

The Blue Thunder Track Club received a donation from Sam's Club for the purchase of uniforms and for paying for the AAU membership and registration for youth to participate in various track meets. The Blue Thunder Club has nearly 100 youth from ages 5 – 16 participating in local and regional meets. The donation was made by Sam's Club to the New Century Fund, Inc., a 501 (c) (3) organization which supports the Cityof Columbia. The New Century Fund accepted the donation and in turn provided the City of Columbia with the \$1,000 earmarked for the Blue Thunder Track program.

The Community Recreation section of the Department organizes a Toys for Columbia's Youth program. This program receives new and gently used toys as well as cash donations in an effort to provide needy families toys for the youth during the holidays. The Department received \$358 from the community this past year and purchased toys for the youth with the funds. The donations were deposited to the Permanent Park Improvement Fund and need to be transferred to the Community Recreation's operating budget. There were 230 youth served by the program in 2007.

The C.A.R.E. Gallery is the arts component of the CARE program. Each year, the artwork is displayed and offered for sale at the end of the program. The Perlow-Stevens Gallery hosted the event this past year. The Gallery has donated \$78 back to the CARE Gallery based upon sales at the event and this amount was placed into the Permanent Park Improvement Fund. This ordinance would allow for those funds to be placed in the CARE Gallery account to be used for the 2008 effort.

The CARE Gallery also received funding for the program through the Missouri Arts Council for a total of \$5,428.00. These funds have been deposited into the Permanent Park Improvement Fund and this ordinance would transfer those funds to the appropriate CARE accounts. The monetary assistance will be used to fund visiting artists for the program and for program-related supplies.

SUGGESTED COUNCIL ACTION:

Approve the ordinance accepting the contributions and appropriating the funds to the proper accounts.
