

Re: Appropriation for Electric Capital Projects

EXECUTIVE SUMMARY:

Staff has prepared for council consideration, an ordinance appropriating funds from retained earnings to three annual electric capital projects. Appropriation amounts are - \$200,000 to EL0021 Distribution Transformers; \$600,000 to EL0115 Substation Feeders; and, \$200,000 to EL0117 Commercial and Multi-family Expansion.

DISCUSSION:

The Columbia Water and Light Department has several capital projects that are funded each fiscal year. During the recent economic downturn, project funding was reduced in recognition of the reduced demand for additional services. During fiscal year 2013, significant activity has drawn down the funding levels in three capital projects to a level that requires additional funds. Project EL0021 purchases distribution transformers. Transformers are stockpiled to address failures and new system growth. Lead time for purchase is often over two months. Project EL0115 covers installation, replacement and realignment of major distribution lines. The current street project on Stadium Boulevard has drawn down this project to a level that can address other system requirements. Project EL0117 pays for the electric utility's share of the infrastructure necessary to serve new commercial and multi-family developments. Recent construction levels have out-paced the current funding in this project.

FISCAL IMPACT:

The total appropriation requested four the three capital projects is \$1,000,000. Funds are available in retained earnings.
