Re: Amending Chapter 2 - Appointment of Temporary Clerk

EXECUTIVE SUMMARY:

Amending Chapter 2 to allow the temporary clerk to automatically be the deputy city clerk.

DISCUSSION:

The FY 2014 budget includes changes to the classification plan with regard to job titles, descriptions, etc., and included in those is a new deputy city clerk position. This replaces an administrative assistant position, which is currently vacant so it is not an additional position, and the number of positions in the city clerk's office will remain the same.

The amendment of Chapter 2 would automatically allow the deputy city clerk to perform the duties of the city clerk when the city clerk is absent or otherwise unable to perform those duties.
