Re: Amendment to R158-13 Authorizing an operations agreement with Thumper Productions, LLC for the 2013 RBBBQ Festival

EXECUTIVE SUMMARY:

Thumper Entertainment has requested two amendments to the written operations agreement: (1) the addition of a ferris wheel to the festival site layout plan; and, Friends of the Festival (a nonprofit corporation) be granted permission to sell alcoholic beverages.

DISCUSSION:

The amendment sheet includes the addition of a ferris wheel at the RBBBQ festival. The Risk Manager is recommending certificate of liability insurance including \$3 million per occurrence/\$10,000,000 aggregate to adequately protect the City of Columbia and match the State of Missouri's sovereign immunity protection for public entities. The requested amounts are equal to the general liability insurance limits maintained by the City. Thumper Productions has agreed to provide the additional coverage as requested by the Risk Manager. Thumper Entertainment will also need to provide verification that the ferris wheel has been inspected and meets the approval of the MO Division of Fire Safety.

Thumper Entertainment is requesting that Friends of the Festival be permitted to sell alcoholic beverages as part of the concessions operations. The Council approved operations agreement grants Thumper Entertainment permission to sell alcoholic beverages as part of the concessions operations. Additional information, including a Certificate of Incorporation Missouri Nonprofit, for Friends of the Festival is attached.
