AN ORDINANCE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:





EXECUTIVE SUMMARY:

A request by the City of Columbia Public Works Department (owner) to vacate and dedicate sanitary sewer easements associated with the PCCE #6 (South Country Club Drive) project. The easement vacations and dedications are located on property addressed as 2215 S. Country Club Drive. (Case # 13-160)

DISCUSSION:




