# AN ORDINANCE

amending Chapter 14 of the City Code as it relates to hourly parking and fees for certain facilities; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 14 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 14-391. Hourly parking; fees for certain facilities.

- (a) Schedule:
- (1) Except as provided in paragraph (d) of this section, and except on Saturdays, Sundays and holidays, parking fees between the hours of 8:00 a.m. and 6:00 p.m. on the municipal parking plaza shall be levied at the rate of twenty-five cents (\$0.25) per half hour or any portion thereof.

For the purpose of determining rates herein, any person failing to present or enclose parking stubs when payment of the parking fee is made shall be deemed to have entered the facility at 7:30-8:00 a.m. on the day such facility is used.

At any time that the city manager determines that it is necessary to assure adequate parking for downtown business customers and to discourage free, long-term weekend parking, the city manager may order the above fees to be levied on Saturdays also.

(2) Except as provided in paragraph (d) of this section, and except on Saturdays, Sundays and holidays, the fee for parking between the hours of 7:30-8:00 a.m. and 6:00 p.m. in the areas designated for public parking in the municipal parking garage located at the northeast corner of Cherry and Eighth Streets shall be twenty-five cents (\$0.25) per half hour.

- (3) Except as provided in paragraph (d) of this section, and except on Saturdays, Sundays and holidays, the fee for parking between the hours of 7:30-8:00 a.m. and 6:00 p.m. in the areas designated for public parking in the municipal parking garage located at the southeast corner of Cherry and Tenth Streets shall be fifty cents (\$0.50) per hour.
- (4) Except as provided in paragraph (d) of this section, and except on Saturdays, Sundays and holidays, the fee for parking between the hours of 7:30-8:00 a.m. and 6:00 p.m. in the areas designated for public parking in the municipal parking garage located at the southwest corner of Cherry and Sixth Streets shall be fifty cents (\$0.50) per hour.
- (5) Except as provided in paragraph (d) of this section, and except on Saturdays, Sundays and holidays, the fee for parking between the hours of 7:30-8:00 a.m. and 6:00 p.m. in the areas designated for public parking in the municipal parking garage located at the southeast corner of Walnut Street and Fifth Street shall be fifty cents (\$0.50) per hour.
- (6) Except as provided in paragraph (d) of this section, and except on Saturdays, Sundays and holidays, the fee for parking between the hours of 8:00 a.m. and 6:00 p.m. in the areas designated for public parking in the municipal parking garage located at the southeast and southwest corners of the Short Street and Walnut Street intersection shall be fifty cents (\$0.50) per hour.
- (b) Payment:
- (1) At the municipal parking plaza the parking fees provided in this section shall be paid in cash or by coupons issued under authority of the city. Such fee shall be paid to the facilities parking attendant during the hours stated herein, or in a drop box at such facility after the hours stated herein and before 7:00 8:00 a.m. of the following day.
- (2) At the municipal parking garage facility located at the northeast corner of Cherry and Eighth Streets the parking fees provided in this section shall be paid, immediately upon parking a vehicle, by depositing a coin of the proper denomination in the meter as stated on the meter, according to the length of time to be parked and shall set the signal on such meter indicating the time limit for parking.
- (3) At the municipal parking facility located at the southeast corner of Cherry and Tenth Streets the parking fees provided in this section shall be paid, upon parking the vehicle and prior to leaving the site, by depositing a coin or bill of the proper denomination, or by credit card, in the multi-space parking

- machine located at the structure's entrance, pursuant to the posted instructions, according to the length of time to be parked.
- (4) At the municipal parking facility located at the southwest corner of Cherry and Sixth Streets the parking fees provided in this section shall be paid, upon parking the vehicle and prior to leaving the site, by depositing a coin or bill of the proper denomination, or by credit card, in the multi-space parking machine located at the structure's entrance, pursuant to the posted instructions, according to the length of time to be parked.
- At the municipal parking facility located at the southeast corner of Walnut and Fifth Streets the parking fees provided in this section shall be paid, upon parking the vehicle and prior to leaving the site, by depositing a coin or bill of the proper denomination, or by credit card, in the multi-space parking machine located at the structure's entrance, pursuant to the posted instructions, according to the length of time to be parked.
- At the municipal parking facility located at the southeast and southwest corners of the Short Street and Walnut Street intersection the parking fees provided in this section shall be paid, upon parking the vehicle and prior to leaving the site, by depositing a coin or bill of the proper denomination, or by credit card, in the multi-space parking machine located at the structure's northeast and southwest stair tower exiting the facility, or credit card only at the structure's northwest stair tower exiting the facility, or by credit card at the pay machine at the exit gate arm, pursuant to the posted instructions, according to the length of time to be parked.

### **EXECUTIVE SUMMARY:**

Staff has prepared for Council consideration legislation amending Section 14-391 of the City Code of Ordinances to add the Short Street parking garage to the list of facilities offering hourly parking, as well as adding language to allow customers to pay for their hourly parking with a credit card at Sixth & Cherry, Tenth & Walnut and Short Street parking facilities, and adjusting the time when hourly parking fees are required.

#### **DISCUSSION:**

This legislation amends Section 14-391 of the City Code of Ordinances as follows:

### (a) Schedule:

Add Short Street parking garage to the list of facilities offering hourly parking.

Adjusting the time that customers are required to pay for hourly parking from 7:30 a.m - 6:00 p.m. to 8:00 a.m. - 6:00 p.m., for all parking facilities .

#### (b) Payment:

Add credit card as a method of payment for hourly parking in the Tenth & Cherry and Sixth & Cherry parking facilities.

Add the 5th & Walnut and the Short Street parking garages to the list of facilities allowing payment, by credit card or cash, for hourly parking.
