AN ORDINANCE

authorizing an amendment to the agreement with the Columbia Public School District to substitute a playground improvement project at West Boulevard Elementary School in place of the New Haven Elementary School playground improvement project; authorizing an agreement with the Columbia Public School District for FY 2014 playground improvement projects at New Haven Elementary School, Parkade Elementary School, Fairview Elementary School and Russell Boulevard Elementary School; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to execute an amendment to the fiscal year 2013 agreement with the Columbia Public School District relating to the construction of a playground improvement project at West Boulevard Elementary School in place of the New Haven Elementary School playground improvement project. The form and content of the amended agreement shall be substantially in the same form as set forth in "Exhibit A" attached hereto.

SECTION 2. The City Manager is hereby authorized to execute an agreement with the Columbia Public School District for fiscal year 2014 playground improvement projects at New Haven Elementary School, Parkade Elementary School, Fairview Elementary School and Russell Boulevard Elementary School. The form and content of the agreement shall be substantially in the same form as set forth in "Exhibit B" attached hereto.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.

AMENDMENT TO AGREEMENT

THIS AMENDMENT TO AGREEMENT is entered into on this _____ day of _____, 2013, by and between the City of Columbia, Missouri, a municipal corporation (hereinafter "City"), and the Columbia Public School District (hereinafter "District").

WHEREAS, City and District entered into an agreement on February 11, 2013 for the construction of a walking/running track at New Haven Elementary School; and

WHEREAS, due to the construction of additional improvements on the New Haven Elementary School property, District is postponing construction of the walking/running track project in the 2012-2013 school year until the 2013-2014 school year; and

WHEREAS, District proposes to substitute construction of a softball/baseball backstop project at West Boulevard Elementary School during the 2012-2013 school year in place of the New Haven Elementary School walking/running track project; and

WHEREAS, the playground facility improvements at Shepard Boulevard Elementary School and Lee Elementary School as described in the February 11, 2013 agreement shall be constructed in the 2012-2013 school year.

NOW, THEREFORE, City and District agree to the following amendments to their agreement of February 11, 2013:

- 1. Construction of a softball/baseball backstop project at West Boulevard Elementary School shall be substituted for all references to the walking/running track improvements at New Haven Elementary School. The softball/baseball backstop project at West Boulevard Elementary School shall be constructed in the 2012-2013 school year in an amount not to exceed Four Thousand Dollars (\$4,000.00).
- 2. All other provisions of the February 11, 2013 agreement shall remain in effect.

AGREEMENT

THIS AGREEMENT dated this _____ day of _____, 2013, is entered into by and between the City of Columbia, Missouri, a municipal corporation (hereinafter "City") and Columbia Public School District (hereinafter "District").

WHEREAS, District is improving the playground facilities at four elementary schools; specifically, New Haven Elementary, Parkade Elementary, Fairview Elementary and Russell Boulevard Elementary; and

WHEREAS, City, in accordance with Policy Resolution 20-98, is willing to participate in funding of the construction of a walking/running track at New Haven Elementary School, construction of new playground equipment at Parkade Elementary School and Fairview Elementary School, and the acquisition and installation of replacement playground equipment at Russell Elementary School; and

WHEREAS, District is willing to make these playground improvements available to the public when the playgrounds are not being used for school activities.

NOW, THEREFORE, City and District agree as follows:

- 1. City will reimburse District in an amount up to Twenty-five Thousand Dollars (\$25,000.00) for improvements to the playgrounds at New Haven Elementary School, Parkade Elementary School, Fairview Elementary School and Russell Boulevard Elementary School. Specific improvements include a new walking/running track at New Haven Elementary School, construction of new playground structures at Parkade Elementary School and Fairview Elementary School, and replacing the existing playground at Russell Boulevard Elementary School. Reimbursement will be made upon receipt of documentation of actual expenditures made by the District with respect to the facility development.
- 2. As a condition of receiving the payment for these improvements, District agrees to:
 - a. Keep its playgrounds at Parkade Elementary School, Fairview Elementary School and Russell Boulevard Elementary School and track at New Haven Elementary School open to the public at all reasonable times when not in use for school activities.
 - b. Submit improvement plans and specifications to City's Parks and Recreation Department for approval.
 - c. Construct the improvements according to the plan submitted.

- d. Hold the City harmless for any and all claims or damages for personal injury or property damage arising out of the use of the playground, whether by students or by members of the public.
- e. Install and maintain a permanent sign on site that indicates: "Partial funding provided by the Park Sales Tax." If requested, Parks & Recreation can provide a sign or the appropriate wording could be worked into an existing sign.

Re: City/School Playground Improvement Agreement: Four Schools

EXECUTIVE SUMMARY:

Since 1998, the City has assisted with the funding of outdoor play equipment at thirteen schools located within the Columbia Public School District (CPSD). The City's FY-2014 CIP budget includes \$25,000 for playground improvements at Parkade, New Haven, Fairview and Russell Elementary Schools. In addition, CPSD is requesting that improvements to the West Boulevard Softball Field replace the 2013 New Haven Elementary Track project. New Haven is undergoing construction and the area will not be ready until 2014. Staff is recommending two agreements: one that approves the projects for FY14 and another that modifies the FY13 agreement. An ordinance is needed to authorize these agreements. The proposed projects have been identified by the School District as their highest priority for the cooperative city/school district playground program for the 2013-2014 school year. The City's funding source for the project comes from the 2010 Park Sales Tax and FY-2014 marks the third year of the five year funding program.

DISCUSSION:

For the City's FY-14 City/School playground improvement grant, the Columbia Public School District has identified four schools: Parkade, New Haven, Fairview and Russell Elementary Schools. The New Haven running track was originally approved in FY-13 but due to ongoing construction at the school, CPSD is requesting that the West Boulevard Elementary School backstop project replace the New Haven project.

Specific projects at each school include:

New Haven: Construct a 10-ft wide, approx 1,300-ft long gravel walking/running track. There used to be an old cinder track that has been overgrown for some time. Budget: \$8,000.

Parkade: Add a new play structure to the playground. Budget: \$4,000

Fairview: Add a new play structure to the playground. Budget: \$6,000

Russell: Replace a smaller play structure. Budget: \$6,000.

Previous projects funded under this policy include Grant (1998), Benton (2000), Field (2000), Lee (2001), West Blvd (2002), Parkade (2004), Mill Creek (2005), Shepard (2006), Blue Ridge (2007), Russell (2007), Ridgeway (2007), Parkade Phase II (2008), Fairview (2009), Derby Ridge (2010), Grant (2011) West Junior (2012) and Shepard, West Blvd (replaces New Haven) and Lee Elementary (2013). No appropriation was funded in FY-2003. These projects have been positively received by both the school and the general public.

This ordinance, if approved, authorizes two agreements with the Columbia Public School District. One agreement authorizes the projects for FY-2014 and provides procedures for implementing the playground improvement project and assures that the facilities will be open for public use. The other agreement modifies the FY-2013 agreement that replaces New Haven with the backstop improvement project at West Boulevard Elementary School. The school district is responsible for the construction and ongoing maintenance relating to these improvements.

FISCAL IMPACT:

\$25,000 has been budgeted for FY-14 City/School Facility Improvements. This funding comes from the 2010 Park Sales Tax. The City will not have any ongoing maintenance costs as the Columbia Public School District is responsible for the maintenance of these improvements. Fiscal Year 2014 marks the third year of the five year funding program.
