**Re:** Sapp - voluntary annexation (Case #13-230)

#### **EXECUTIVE SUMMARY:**

A request by Robert Laverne Sapp and Jane Sapp (owners) to annex 14.36 acres of land into the city of Columbia, and to assign R-1 (One-Family Dwelling District) as permanent City zoning. The subject site is located on the northwest corner of Scott Boulevard and Highway KK, and is addressed 5801 S. Highway KK (Case #13-230).

#### **DISCUSSION:**

The request is to annex the property so that it may be combined with adjacent parcels to the north and west (already within city limits) to create an approximately 30-acre lot for a public elementary school and potential City neighborhood park. The subject site is contiguous with the city limits, and the applicant is requesting R-1 (One-Family Dwelling District) zoning, which is consistent with the property's current Boone County R-S (Single-family Residential) zoning designation.

The site is developed with a single-family home which would be removed prior to redevelopment. Water and sanitary sewer service is provided by the City of Columbia. Boone Electric Cooperative supplies electricity to the property. Boone County Fire Protection District currently serves the site; however, the Columbia Fire Department will assume fire protection duties upon annexation.

The proposed urban service area in Columbia Imagined straddles the subject property, with the already annexed acreage, Thornbrook Subdivision, Steeplechase Estates, and several other city subdivisions defining the urban service area boundary at the southwest side of Columbia.

The Planning and Zoning Commission will make a recommendation to the City Council on the permanent zoning request at its December 19, 2013 meeting.






