AN ORDINANCE

determining it is in the public interest to construct restroom projects at the Garth Nature Area and Grindstone Nature Area; approving and adopting plans and specifications; determining that a portion of the work shall be done by contract; calling for bids through the Purchasing Division; determining that a portion of the project shall be done by city employees; providing for payment for the improvement; authorizing the City Manager to obtain, execute and record all documents necessary for the improvement; providing for compliance with the prevailing wage law and state-mandated construction safety training; and fixing the time when this ordinance shall become effective.

WHEREAS, the City Council adopted a resolution declaring the necessity of constructing restroom projects at the Garth Nature Area and Grindstone Nature Area; and

WHEREAS, the notice of a public hearing on this project was published in a daily newspaper of general circulation in the city; and

WHEREAS, the City Council has held a public hearing on construction of the improvement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds that the construction of restroom projects at the Garth Nature Area and Grindstone Nature Area in the City of Columbia, Missouri, is necessary for the welfare and improvement of the city and that it is in the public interest that such improvements be made. Specific improvements include:

- 1. <u>Grindstone Nature Area</u>: Installation of a precast concrete restroom facility, associated utilities and concrete flatwork.
- 2. <u>Garth Nature Area</u>: Installation of a precast concrete restroom facility, associated utilities, concrete flatwork and dog park improvements.

SECTION 2. The plans and specifications for this improvement, as prepared by the Director of Parks and Recreation, are hereby approved and made a part of this ordinance by reference.

SECTION 3. A portion of the construction of the improvement shall be done by contract in accordance with the plans and specifications, the laws of the State of Missouri, and the Charter and Ordinances of the City of Columbia, Missouri.

SECTION 4. The Purchasing Agent is hereby authorized to call for bids and execute a contract for the sewer and concrete work and installation of the restrooms. As deemed advisable by the City Manager, city employees shall be used for the electrical work including the Garth Nature Area dog park aeration and lights.

SECTION 5. Payment for this improvement shall be made from Parks Sales Tax Funds and such other funds as may be lawfully appropriated.

SECTION 6. The City Manager is authorized to obtain, execute and have recorded all licenses, easements, deeds and any other conveyances or instruments necessary for the City to complete this improvement.

SECTION 7. The contract for the improvement shall provide that not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under the contract. The contractor's bond shall guarantee the faithful performance of the prevailing hourly wage clause in the contract.

SECTION 8. The bid specifications and contract for the improvement shall provide that the contractor and any subcontractor shall provide a ten-hour Occupational Safety and Health Administration construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations) for all employees working on-site. All employees working on the site of the improvement are required to complete the safety program within 60 days of beginning work on the improvement project.

SECTION 9. This ordinance shall be in full force and effect from and after its passage.

Re: Garth Nature Area / Grindstone Nature Area Restrooms

EXECUTIVE SUMMARY:

The Parks & Recreation Department is requesting Council approval to proceed with new restrooms at the Garth Nature Area and Grindstone Nature Area. As shown in the City's FY-2014 CIP, the department is recommending the addition of a restroom at Garth Nature Area to service the park property as well as Bear Creek Trail users. The restroom facility at Grindstone Nature Area will be utilized by visitors at the nature area as well as individuals utilizing the Hinkson Creek Trail. The project budget for the Grindstone Nature Area restroom is \$100,000 and includes the installation of the restroom and associated utilities and concrete flatwork. The project budget for the Garth Nature Area restroom is \$115,000 and includes the installation of the restroom, associated utilities, concrete flatwork and dog park improvements. Both restroom projects are funded by the 2010 Park Sales Tax. The project will be bid through the City's Purchasing Department and will be completed using a combination of contract and force account labor. Work is scheduled to begin this summer with the goal of having the restrooms operational by the fall.

DISCUSSION:

The Parks and Recreation Department is proposing to install precast concrete restroom facilities at two locations within Columbia. The restrooms at Garth Nature Area (attachment A) and Grindstone Nature Area (attachment B) are needed due to increased citizen use at each nature area, as well as the increased traffic along the two major trails that run through the properties. The Hinkson Creek Trail is constructed within the Grindstone Nature Area, and the Bear Creek Trail runs through The Garth Nature Area. Park staff identified these two locations due to their proximity to major park properties and as important trail access points with parking. The two restroom facilities will also replace portable toilets located at each location.

After each restroom location was determined, park planning staff held an an interested parties meeting at the ARC on Thursday, March 20 to present the proposed restroom projects to the public. Approximately 10 individuals attended the meeting to discuss the improvements. After the conclusion of the public interest meeting, park staff made minor modifications to the plans, and the project plans were finalized.

Park staff is proposing to install a small, precast concrete restroom, approximately 136 sq. ft., at each location. The proposed restroom facilities at each park property will be similar to the facilities that have been installed along the MKT Trail at Scott Boulevard and Forum Boulevard and commonly found in Missouri State Parks. The installation of each restroom will include the installation of all necessary utilities and concrete flatwork around each restroom to accommodate ADA accessibility.

Staff is also proposing to complete three projects at the Garth Dog Park during the restroom installation project. The improvements include additional lighting from the Garth parking lot to the dog park entrance, sub-surface aeration in the lake at the dog park, and the addition of an ADA walkway within the dog park. The 6 foot ADA walkway was a recommendation made by citizens during the interested parties meeting due to limited access to the dog park for individuals with a disability.

The proposed restroom facilities at Grindstone Nature Area and Garth Nature Area are funded in the City's FY14 Capital Improvement Program budget, with site construction scheduled to begin this spring. Staff anticipates that all work will be completed by fall 2014. All work and materials will be bid through the City's Purchasing Department and will be completed using a combination of contract and force account labor. Staff anticipates contracting the sewer lines, concrete and installation of the restroom. Park staff will do electrical work including the Garth dog park aeration and lights.

FISCAL IMPACT:

The project budget for the Grindstone Nature Area restroom is \$100,000 and the project budget for the Garth Nature Area restroom is \$115,000. The projects are funded by the 2010 Park Sales Tax. Staff anticipates higher utility installation costs at the Garth Nature Area due to utility availability in the area. The on-going costs associated with water, sewer and electric utilities will be offset by the elimination of portable toilet costs at each site.






