Please consider making a recommendation to the City Council to either change or repeal ordinance 16-283 requiring registration of sound amplifying equipment. The ordinance reads as follows:

"Section 16-283 Noncommercial use--Registration statement required.

Before any person shall use, or cause to be used, sound amplifying equipment, a sound truck or other conveyance with its sound amplifying equipment in operation for noncommercial purposes on any street in the city, or in the air above the city, and before any person shall use, or cause to be used, any sound amplifying equipment in any public park or public playground in the city, he shall file a registration statement with the chief of police or other member of the police department authorized by the chief to accept such registration."

As best I can tell, the ordinance was passed in 1964 and does not appear to be useful in its current form. The vast majority of these registration forms we currently receive are for events being held in city parks. Most of these are for relatively small, private gatherings such as wedding receptions. The applicants are usually made aware of the requirement while completing the special use permit process for Parks and Rec, so that department is already aware of the events. We also receive a few of these forms related to larger events, such as Roots N Blues. Since larger events held on public property go through the City Event Committee process, city departments are already aware of these events also.

Not only does the sound amplification registration process appear to be extraneous and unnecessary, but it can also be confusing to the registrants. Many registrants believe that by registering their sound amplification equipment, they are exempt from the peace disturbance and noise ordinances (although the form clearly states approval of the form does NOT permit violation of these ordinances).

Since there are already processes in place to review and approve events through the Parks and Rec Department and the City Event Committee, the requirement for registration of sound amplifying equipment no longer appears to be necessary to make the Police Department or other City departments aware of these events. I believe additional questions could be added to the Parks and Rec and Special Event Applications to gather the information related to sound amplification for an event if such information is deemed necessary. In addition, if they agree to do so, I think it would be helpful for Parks and Rec to provide applicants with information about the applicable peace disturbance and noise ordinances at the time a Parks Special Use Permit is approved.
