Re: Public Hearing - PCCE #3 - Stewart/Ridge/Medavista Sewer Improvement Project

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration legislation setting a public hearing for April 21, 2014 concerning the construction of sanitary sewers to serve properties located within PCCE #3 - Stewart/Ridge/Medavista Sewer Improvement project, which also includes homes along Tracy Drive, Crestland Avenue, and West Boulevard, as shown on the attached diagram. The proposed sewer improvement project consists of fifty-five (55) parcels of land, with fifty-two (52) of these parcels served by four (4) separate private common collector (PCC) sewers. The resolution estimate for this PCCE project is \$1,515,000, and payment shall come from Annual Private Common Collector Elimination funds.

DISCUSSION:

The properties currently connected to the PCC sewers in this area have been experiencing problems with stoppages, backups and overflows due to the deteriorated condition of the private common collector sewer. City sewer maintenance crews have responded to several sanitary sewer overflows of these private common collector sewers; and the Health Department and MoDNR have both been contacted by local residents regarding potential health and safety problems associated with the overflows. The private common collector sewers are in poor structural condition and do not meet City standards.

In April 2002, MoDNR investigated a complaint due to odor from one of the private common collectors and requested the City address a long term solution with the homeowners in the area. Council then directed staff to proceed with the preliminary design and to determine the feasibility and costs of a sewer improvement project for this area. Staff held an Interested Parties (IP) meeting for the project on March 18, 2009, and two additional IP meetings (this time breaking the project into two separate IP meeting areas) on September 25 and 26, 2013. Since then, staff has attempted to contact the property owners that did not attend the IP meetings by letter, and then by door knocking. There are seven (7) property owners out of the fifty-five (55) that would be affected by construction of this project that staff has been unable to contact. All seven (7) of these properties are currently served by one (1) of the private common collectors mentioned. Staff has been meeting onsite with property owners to discuss the alignment and impacts to the properties, and will continue doing so in the final design stage. Out of the remaining 45 properties that are currently served by the private common collectors in the area, 44 have indicated their support of the project, and one (1) has indicated hesitation due to the potential impact of the property. Staff is working with the property owners of the three properties that do not need the new sewer, to attempt an alignment solution that is agreeable to all parties.

This project will consist of constructing approximately 4,800 linear feet of gravity sewer and will include new private service connections and replacement of service laterals required to reconnect the existing structures to the new sewer main. Staff intends to phase the construction of this project into smaller areas based on easement acquisition. The resolution estimate for this project is \$1,515,000, which includes design, construction, and anticipated easement acquisition costs. In accordance with Section 22-253 of City code, financing for this project will be through Sewer Utility - Private Common Collector Elimination funds.

FISCAL IMPACT:

The resolution estimate for the project is \$1,515,000, and funding shall come from Annual Private Common Collector funds provided in the April 2008 and November 2013 ballots. To date, \$659,000 has been transferred to this project with the remaining balance needed from Private Common Collector Funds and Sanitary Sewer Utility CIP. It is anticipated that this project will have minimal impact on the sewer utility's operating cost annually.

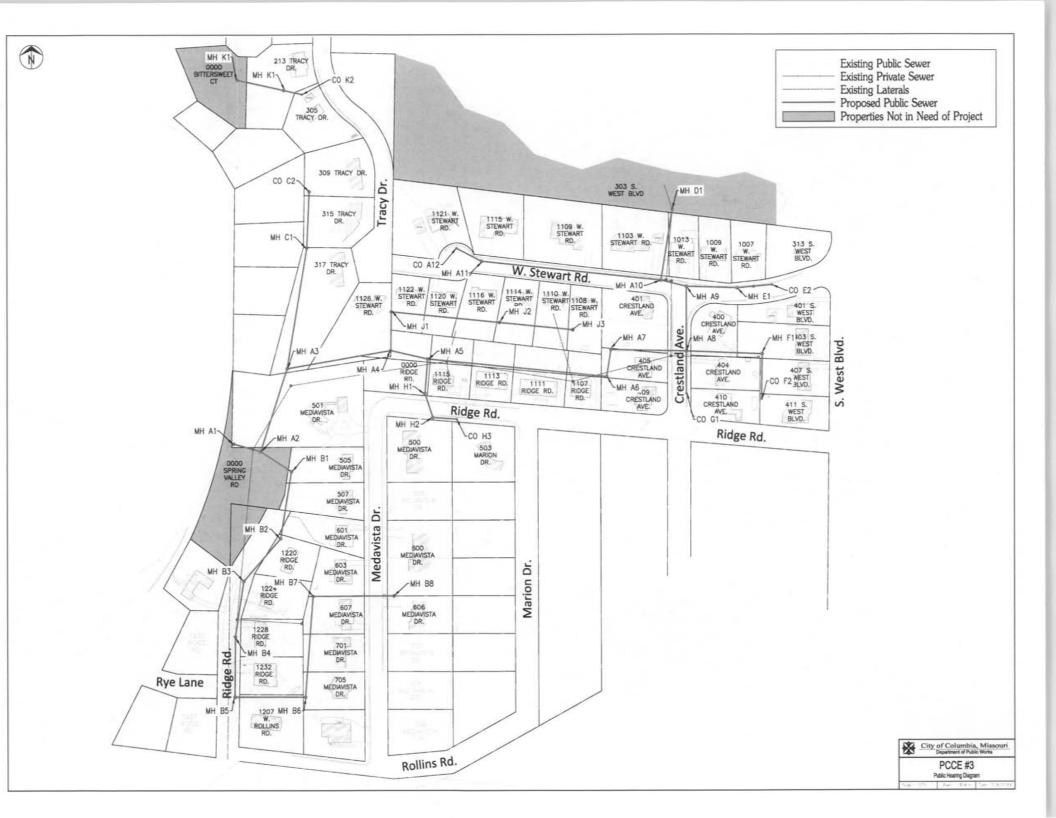

A RESOLUTION

declaring the necessity for construction of the Stewart/Ridge/Medavista PCCE #3 Sanitary Sewer Improvement Project; stating the nature of and the estimate of the cost of the improvement; providing for payment for the improvement; providing for compliance with the prevailing wage law; and setting a public hearing.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems the construction of sanitary sewers, wye branches, manholes and other necessary appurtenances all in accordance with City of Columbia Street and Storm Sewer Specifications and Standards, as part of the Stewart/Ridge/Medavista PCCE #3 Sanitary Sewer Improvement Project, necessary to the welfare and improvement of the City.

SECTION 2. The nature and scope of the improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements.

SECTION 3. The estimated cost of this improvement is \$1,515,000.00.

SECTION 4. Payment for this improvement shall be made from sewer system revenue bonds and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.

SECTION 6. A public hearing in respect to this improvement will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on April 21, 2014. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.
