## Executive Summary

A request by T.K. Livingston (contract purchaser) to annex 2.0 acres into the City of Columbia and assign C-3 (General Business District) as permanent City zoning. The subject site is located on the north side of Prathersville Rd, approximately 400 feet east of St Hwy 763. (Case #14-54)

## Discussion


The applicant is requesting the annexation of 2.0 acres into the City of Columbia municipal area and a permanent zoning of C-3 (General Business District). The subject property is contiguous with property currently within the City's municipal boundary to the south and across the Prathersville Road right of way.

The site is improved with multiple buildings that are utilized by Same Day Affordable Service, an HVAC company, and a U-Haul vehicle rental business. Pacific Gas also leases a portion of the property and has a facility on the south end of the lot. The County zoning is R-M (Moderate Density Residential), however, the property is currently utilized with commercial uses. The County zoning to the west is C-G (General Commercial) and to the east is M-LP (Planned Industrial).

Currently the site has an on-site lagoon, and the applicant has indicated that connection to the City sanitary system will be sought upon annexation. The property receives water from the City of Columbia, electricity from Boone County Electric Cooperative, and fire protection from the Boone County Fire Protection District. Upon annexation the property would be served by the Columbia Fire Department per the territorial agreement. The property is located within the urban service area as indicated in Columbia Imagined and on the attached locator maps.

The Planning and Zoning Commission will make a recommendation to the City Council on the permanent zoning request at its May 8, 2014 meeting.

## Fiscal Impact

**Short-Term Impact:** As an already developed property, Columbia will gain taxes and fees for service as a result of the annexation. Costs cannot be estimated as the demands on public services of a single commercial property cannot be predicted. The City will not be responsible for any additional public infrastructure as a result of this annexation.

**Long-Term Impact:** In the event additional properties along Prathersville Road are considered for annexation, the costs of roadway maintenance (Prathersville Road is County jurisdiction) and possibly additional infrastructure investments may be weighed against the benefits of additional revenues. No additional requests for annexation on the Prathersville Road corridor are under review at this time.


- 2. This real estate is not now a part of any incorporated municipality.






# 14-54: 1339 Prathersville Road Annexation & Zoning
