Executive Summary

Staff has prepared for Council consideration an ordinance authorizing the City Manager to execute a Customer Exchange Agreement between the City of Columbia and Boone Electric Cooperative. This Customer Exchange Agreement transfers the right of providing electric services to twenty-nine (29) customers' structures within the City's corporate boundaries from Boone Electric Cooperative to the City of Columbia.

Discussion

Boone Electric's distribution lines currently serving the twenty-nine (29) customers was constructed in the 1960's, prior to the March 28, 1989 approval of the Territorial Agreement. Boone Electric's system supplying electric service to these customers consists of approximately 16 lights, 61 poles and 29,600 feet of primary conductor. The location of the Cooperative distribution line is located such as to prevent development of five existing lots that currently contain no structures. The City has nearby, adequate facilities and would be well placed to serve the existing customer structures and as such the transfer of electric right of service has been determined to be in the public good. The cost for exchange of these customers will include transformer and metering changes. As further development in the area occurs, we are planning for the system to be transitioned to an underground loop feed system.

Upon approval of this request for customer exchange, City of Columbia and Boone Electric Cooperative will file jointly for change of electric supplier with the Missouri Public Service Commission. Upon approval from the Missouri Public Service Commission, the City of Columbia and Boone Electric will work to minimize the impact to customers in the transition of electric service provider.

AN ORDINANCE

approving the transfer of customers and sale of facilities from Boone Electric Cooperative to the City of Columbia under the territorial agreement with Boone Electric Cooperative; authorizing a Customer Exchange Agreement with Boone Electric Cooperative; authorizing a Contract for Purchase and Sale of Distribution Facilities with Boone Electric Cooperative; authorizing the City Manager to make joint application to the public service commission and to take any other required actions with Boone Electric Cooperative for the exchange of customers; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby approves the transfer of twenty-nine (29) Boone Electric Cooperative customers to the City of Columbia, Missouri. The City Council hereby finds the mutual consent of the parties and that the transfer of utility service to be a benefit to both Boone Electric and the City of Columbia and to the public.

SECTION 2. The City Manager is hereby authorized to execute a Customer Exchange Agreement with Boone Electric Cooperative. The form and content of the agreement shall be substantially in the same form as set forth in "Attachment A" attached hereto.

SECTION 3. The City Manager is hereby authorized to execute a Contract for Purchase and Sale of Distribution Facilities with Boone Electric Cooperative. The form and content of the agreement shall be substantially in the same form as set forth in "Attachment B" attached hereto.

SECTION 4. The City Manager is authorized to make joint application to the Public Service Commission for any necessary approvals for the customer exchange and take any other required actions with Boone Electric Cooperative for the exchange of the customers.

SECTION 5. This ordinance shall be in full force and effect from and after its passage.

CUSTOMER EXCHANGE AGREEMENT

T	his Customer Exchange	Agreement ("Agreement") is m	ade and entered into as of the
da	ay of	, 2014, by and between CITY	OF COLUMBIA, MISSOURI
(hereinaf	ter "City") and BOONE	ELECTRIC COOPERATIVE (he	ereinafter "Cooperative").

RECITALS

- A. City is authorized by law to provide municipally owned electric service within the City of Columbia, State of Missouri;
- B. Cooperative is authorized by law to provide electric service within the State of Missouri, including all of Boone County;
- C. City and Cooperative entered into a Territorial Agreement on October 17, 1988 which received approval by a March 28, 1989 Report and Order of the Missouri Public Service Commission with an effective date of April 7, 1989.
- D. The Missouri Legislature provides for a change in electric supplier from Cooperative to City pursuant to Sections 91.025 and 394.315 RSMo. 2000;
- E. City and Cooperative desire to transfer the electric service of twenty-nine (29) active customer structures located inside of the City's corporate boundaries from Cooperative to City;
- E. These 29 customers' structures are, pursuant to the terms of the PSC approved Territorial Agreement, lawfully receiving permanent electric service from the Cooperative;
- F. The Cooperative line serving these 29 customers is a radial line consisting of approximately 16 lights, 61 poles, and 29,600 feet of various sized primary conductor dating back to the 1960's;
- G. The location of the Cooperative distribution line serving these 29 customer structures is located such as to prevent development of five existing development lots that currently contain no structures. These five lots cannot be developed as any such construction would violate the applicable minimum approach distances as set forth in the NESC. Furthermore, the Cooperative line contains a grandfathered NESC violation involving the distribution line crossing over atop an existing structure;
- H. The City has nearby, adequate facilities and would be well placed to serve the 29 existing customer structures served by the Cooperative distribution line and any new structures constructed upon the five existing lots. The City's provision of service to the existing 29 structures and any new structures would not violate minimum approach distances, would be more efficient and economical than the options for similar service by the Cooperative; and

I. By this Customer Exchange the City and Cooperative desire to promote the orderly development of the retail electric service within Boone County and in areas within the limits of the City, and to reduce the wasteful duplication of customer service equipment and offer an improved level of service to their respective customers. This Customer Exchange will also allow emergency personnel to know with certainty the supplier of electric service to the different structures in the area in which these 29 existing customers' structures are located.

AGREEMENT

For good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Parties agree to the following customer exchange:

- 1. Pursuant to Sections 91.025 and 394.315 RSMo 2000, City and Cooperative desire to transfer the electric service of twenty-nine (29) customers' structures located within the corporate boundaries of the City from Cooperative to City and when possible, with the agreement and consent of the affected customers. See **Attachment No. 1**, names and addresses of 29 affected consumers. Consent Affidavits from 25 of the 29 affected consumers is attached hereto as **Attachment 2** and contains each consenting customer's signature and service address. **Attachment No. 3** discussed below depicts the physical location of each customer subject to this Customer Exchange Agreement.
- 2. Pursuant to Sections 91.025 and 394.315 RSMo 2000, City and Cooperative desire to transfer exclusive electric service from Cooperative to City for the twenty-nine customers' structures at issue here, located along the Cooperative's facilities as described in **Attachment No. 3**, which are color coded maps showing the location of customers and facilities to be exchanged from the Cooperative to the City, and the requisite new facilities believed to be necessary by City to provide service to the exchanged customers.

The parties agree to transfer, upon receiving the appropriate Missouri Public Service Commission approval, the electric service from the Cooperative to City for the twenty-nine customers' structures at issue here. This exchange will aid the City and Cooperative in the consolidation of facilities and bring efficiencies and savings to the City and Cooperative. This transfer will promote efficiencies in providing services to those remaining consumers served by the City, and it requires no duplication of electric service facilities as the City intends to purchase the portion of the Cooperative's facilities used to service these twenty-nine customer structures, to upgrade these facilities, and use them to provide service to these twenty-nine customers as well as new structures to built in this vicinity in the future. Furthermore, this transfer will also improve safety in that it allows emergency personnel to know with certainty the supplier of electric service to the different structures in the area in which these twenty-nine customers' structures are located. The twenty-nine customers subject to the exchange will benefit as the City intends to upgrade lines and services to these structures, resulting in greater reliability and quality of service;

- 3. The parties agree to undertake all actions reasonably necessary to implement this Agreement. Cooperative and City will equally pay the cost of obtaining Missouri Public Service Commission approval of the proposed Customer Exchange. Each party will cooperate in presenting a joint application showing such Customer Exchange Agreement to be in the public interest. If the Public Service Commission does not approve the Customer Exchange, then it shall be nullified and of no legal effect between the parties, and the Cooperative shall continue to have the right to continue to serve the twenty-nine customers' structures at issue herein.
- 4. City and Cooperative will strive to obtain the consent of all 29 affected consumers. Failure to obtain the consent of all 29 customers shall not invalidate this Customer

Exchange Agreement and the parties shall jointly proceed with applying for approval of the intended customer exchange with the Public Service Commission regardless of the number of affected consumers granting their consent.









CONTRACT FOR PURCHASE AND SALE OF DISTRIBUTION FACILITIES

THIS AGREEMENT ("Agreement") made and entered into the day of,
2014, by and between BOONE ELECTRIC COOPERATIVE, a Missouri corporation (hereinafter
referred to as "Seller") and CITY OF COLUMBIA, MISSOURI, a Missouri Home Rule city located in
Boone County, Missouri, (hereinafter referred to as the "Buyer") and collectively referred to herein as
"the Parties".

RECITALS

- A. Seller and Buyer are authorized by law to provide electric service within the State of Missouri, including portions of Boone County;
- B. Seller and Buyer have entered into a Customer Exchange Agreement setting forth a proposed change of electric service provider from Seller to Buyer for twenty-nine consumer structures, which are listed in **Exhibit A** attached hereto and made a part hereof for all purposes;
- C. Seller and Buyer believe that these twenty-nine consumer structures may be more efficiently served by Buyer;
- E. Seller presently owns and operates certain distribution facilities excluding revenue meters (hereinafter referred to as the "Facilities"), which are more particularly described in **Exhibit B** attached hereto and made a part hereof for all purposes;
- F. Seller desires to sell and transfer the Facilities and all rights to operate and maintain such Facilities, to the extent that it may legally and contractually do so, to Buyer, and Buyer desires to purchase and accept same, all pursuant to the terms, conditions and provisions hereof.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

ARTICLE I PURCHASE PRICE

- A. **Agreement to Sell and to Purchase.** Seller hereby agrees to sell and transfer to Buyer, and Buyer hereby agrees to purchase and accept from Seller all of Seller's Facilities as set forth and described on **Exhibit B** and all rights, privileges and obligations associated with said Facilities.
- B. **Purchase Price.** The Purchase Price shall be \$1.00, the receipt and sufficiency of which are hereby acknowledged by Seller.

ARTICLE II CONDITIONS

- A. **Effective Date**. This Agreement shall be effective as of the effective date of the Order of the Missouri Public Service Commission approving the Joint Application For Customer Exchange regarding the 29 consumer structures set forth in Exhibit A, to be filed jointly by the Parties.
- B. **Overall Conditions.** Except as otherwise provided herein, this Agreement is contingent upon all of the following having occurred:
 - 1. Approval of the Board of Directors of Seller.
 - 2. Approval of the City Council of Buyer.
- C. Customers. Seller shall transfer all twenty-nine of its customers being served by the Facilities to Buyer on the date of closing simultaneous with the Facilities serving the customers. Seller shall issue to each customer served by the facilities sold pursuant to this agreement, a final bill, reduced by any applicable deposit, credit or refund due and owing them, including all their equity amounts in Seller.
- D. Accounts Receivable. Seller shall retain all accounts receivable related to Seller's electric business through the time that the Customers are transferred from Seller to Buyer. After physical transfer of service from Seller to Buyer, Seller shall issue a final invoice to each of the transferred consumers set forth on Exhibit A.

ARTICLE III INTERIM OPERATIONS

- A. Responsibilities of Buyer and Seller. Until the Customers are physically removed within ten (10) days after the Effective Date, from Seller's system and connected to Buyer's system, Seller will continue to provide electricity, read meters and bill the customers. Upon connection to Buyer's system, the Buyer shall take responsibility for the operation and maintenance of the Facilities. Seller and Buyer agree to cooperate during this transition period (hereinafter the "Interim Period") in order to minimize any adverse impact on the customers.
- B. Emergency Calls. Seller shall respond to emergency service calls up until Buyer physically connects its system to the Facilities serving a customer. Thereafter, Buyer shall respond to all emergency service calls.

ARTICLE IV REPRESENTATIONS AND WARRANTIES

Seller. Seller represents and warrants to Buyer and agrees with Buyer as follows:

- 1. **Title.** Seller warrants to Buyer that (1) Seller will transfer to Buyer good and marketable title to facilities transferred under this Agreement, free and clear of any security interest, liens, encumbrances, or adverse claim of any third party.
- 2. Fitness of Property. Except as hereafter provided, the Facilities sold and transferred pursuant to this Agreement are sold by Seller and purchased by Buyer "AS IS," and SELLER DISCLAIMS ALL WARRANTIES OF ANY KIND, WHETHER STATUTORY, WRITTEN, ORAL, EXPRESSED, OR IMPLIED WITH REGARD TO THE FACILITIES, INCLUDING ALL WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE OF **TRADE.** Except as otherwise provided herein, in no event shall Seller be liable for any damages, including, but not limited to, special, direct, indirect or consequential damages arising out of, or in connection with, the use or performance of the Facilities. Any description of the Facilities contained in this Agreement is for the sole purpose of identifying the Facilities, is not a part of the basis of the bargain, does not constitute a warranty that the Facilities shall conform to that description, and does not constitute a warranty that the Facilities will be fit for a particular purpose. No affirmation of fact or promise made by Seller, not contained in this Agreement, shall constitute a warranty that the Facilities will conform to the affirmation or promise.

ARTICLE V MISCELLANEOUS

- A. Effect of This Agreement on Existing Territorial Agreement. The parties have entered into a Territorial Agreement, which establishes territorial boundaries for the two parties and provides for the exclusive right to service all "new" customers in such territories, which was approved by Report and Order of the Commission dated March 28, 1989 in Case #OA-89-130. This Agreement has no impact whatsoever on the Territorial Agreement. Notwithstanding the foregoing, this Agreement is a complete contract and contains the entire agreement between the parties relating to the subject matter hereof. All prior communications, whether written or oral, are hereby superseded, abrogated, and withdrawn.
- B. Amendments. No modification, amendment, deletion, or other change in this Agreement shall be effective for any purpose unless specifically set forth in writing and signed by both parties hereto.

C. **Headings.** Headings and titles contained in this Agreement are included for convenience only and shall not be considered for purposes of interpretation of this Agreement.

The structures of the twenty-nine (29) customers served are located within the City's corporate boundaries and within the exclusive service territory of City as assigned by the Commission approved Territorial Agreement.

Twenty-seven of the structures are residential and two are non-residential structures. The Applicants, pursuant to Sections 91.025 and 394.315 RSMo 2000, state as follows:

1. The Applicants -- City is a Home Rule municipality organized and existing under the Article VI, Section 19 of the Constitution of the State of Missouri, in good standing in all respects, with its principal office and place of business located at City of Columbia, 701 East Broadway, Columbia, Missouri 65201. City operates a municipal electrical utility engaged in the sale and distribution of electricity in the City of Columbia, Missouri, located in Boone County.

Cooperative is a corporation organized and existing under the laws of the state of Missouri and has its principal office at 1413 Rangeline, Columbia, Missouri 65205.

Cooperative is a Missouri corporation organized as rural electric cooperative corporation pursuant to Chapter 394 of the Revised Statutes of Missouri and is engaged in the distribution of electric energy and services to its members within Boone, Audrain, Callaway, Howard, Monroe and Randolph Counties in Missouri.

3. Change in Supplier – Cooperative supplies retail electric energy through permanent facilities to the twenty-nine customers' structures listed on the Customer Exchange Agreement, located within the City's corporate boundaries. Applicants are requesting to transfer from Cooperative to City these twenty-nine customers' structures in Boone County, and their related electric service accounts. The City and the Cooperative are interested in the customer exchange for reasons other than a rate differential. The Customer Exchange Agreement between

the City and Cooperative, is attached hereto as **Exhibit 1** and is hereby incorporated by reference and made a part hereof for all purposes. Attached to the Customer Exchange Agreement is the consents of twenty-seven (25) of the twenty-nine (29) customers with affected structures.

Applicants seek an order from the Commission approving a change in supplier as to all twenty-nine customers from Cooperative to City pursuant to Sections 91.025 and 394.315 RSMo 2000.

- 4. The Customer Exchange -- Applicants seek a Customer Exchange, which simply transfers the right of providing electric service to the twenty-nine customers' structures within the City's corporate boundaries from the Cooperative to the City. The twenty-nine customers' structures are, per the approved Territorial Agreement, within the exclusive service territory assigned to City. Applicants are not requesting any change to the existing service boundaries of either electric service provider as previously approved by Report and Order dated March 28, 1989 of the Commission in Case #OA-89-130, approving a Territorial Agreement between the City and Cooperative.
- 5. **Resolutions of Boards of Directors** -- A certified copy of the resolution of the Board of Directors of Cooperative authorizing the consummation of the transaction contemplated by this Joint Application is also attached hereto as **Exhibit 2**, is incorporated by reference and made a part hereof for all purposes.

A certified copy of the ordinance of the City Council of the City of Columbia,

Missouri authorizing the consummation of the transaction contemplated by this Joint Application
is attached hereto as **Exhibit 3**, is incorporated by reference and made a part hereof for all
purposes.

- 6. **Certificate of Good Standing** The Cooperative's Certificate of Good Standing issued by the Missouri Secretary of State is attached hereto as **Exhibit 4.** The City of Columbia is a Home Rule city.
- 7. Tax Impact Statement The exchange of these twenty-nine (29) customers will have a de minimis tax impact, if any. The transfer of service will simply involve discontinuing use of the line by the Cooperative to serve these twenty-nine customers' structures. The City intends, and as discussed below in paragraph 9, will upon approval of the Customer Exchange Agreement, purchase the portion of the Cooperative's facilities used to service these twenty-nine (29) customers, upgrade these facilities or replace such facilities so as to provide electric service to these twenty-nine (29) customers as well as new structures to be built in the future in this vicinity.
- 8. Right to Serve -- The Cooperative is authorized by law to provide electric service within rural areas of the State of Missouri. The City of Columbia is authorized by law to provide municipally owned electric service within the City of Columbia, State of Missouri. The twenty-nine customers' structures that are the subject of the Customer Exchange Agreement are lawfully receiving permanent service from the Cooperative as such electric service from Cooperative predates a Commission approved Territorial Agreement (Case #OA-89-130) wherein the physical location of the twenty-nine (29) customer structures was assigned to the City as its exclusive service territory. Said Territorial Agreement provided that the City and Cooperative were each to continue providing electric service to those customers and structures each was serving as of the date of the agreement. The twenty-nine customers' structures that are the subject of the Customer Exchange Agreement are lawfully receiving service from the Cooperative.

- 9. The Customer Exchange is in the Public Interest -- City and Cooperative desire to transfer the electric service of twenty-nine customers' structures located inside of the City's corporate boundaries from Cooperative to City. The electric distribution line serving these twenty-nine customers' structures was constructed in the 1960's and presently is in need of upgrades and reconstruction to assure reliable service into the future. The physical location of portions of the Cooperative line serving these twenty-nine customer structures is such that access for maintenance and restoration work is difficult and slow with current-day equipment and vehicles. The existing location of the electric line is also, so as to not be in violation of the NESC, preventing development of five (5) existing building lots. The City is in a good position to take over the service to the twenty-nine customers' structures as they have nearby facilities that are more than adequate to undertake the electric load and would not require substantial construction of new facilities by the City. The City could serve the existing and any new structures in the vicinity of these twenty-nine customers' structures more efficiently and economically than the Cooperative. This exchange will aid the City and Cooperative in the consolidation of facilities and bring efficiencies and savings to the City and Cooperative. This transfer will promote efficiencies in providing services to those remaining consumers served by the Cooperative, and it requires no duplication of electric service facilities. Furthermore, this transfer will improve safety in that it allows emergency personnel to know with certainty the supplier of electric service to the different structures in the area in which these twenty-nine customers' structures are located. This exchange is in the public interest for reason other than a rate differential.
- 10. **Judgments, Actions and Fees** City has no final unsatisfied judgments or decisions against it from any state or federal agency or court that involve customer service or

rates, which judgments or decisions have occurred within three (3) years of the date of this Joint Application. Further, City has no actions in state and federal agencies and courts involving customer service or rates. City has no annual report or assessment fees that are overdue to this Commission.

Cooperative also has no final unsatisfied judgments or decisions against it from any state or federal agency or court that involve customer service or rates, which judgments or decisions have occurred within three (3) years of the date of this Joint Application. Further, Cooperative has no actions in state and federal agencies and courts involving customer service or rates. Cooperative has no annual report or assessment fees that are overdue to this Commission.

WHEREFORE, City and Cooperative respectfully request that the Commission issue an order:

(1) finding that the requested change in electric service provider as set forth by the Applicants in the Customer Exchange Agreement, which is attached as Exhibit 1 hereto, is not detrimental to the public interest, and approving the Customer Exchange Agreement which provides for the change in electric supplier for the designated twenty-nine customer structures from Cooperative to City for reasons other than a rate differential; and

(2) granting such other relief as is deemed necessary to accomplish the purposes of this Joint Application.
