

## Executive Summary

Amend Chapter 14 of the City Code to temporarily relocate a designated taxi stand on Tenth Street, just north of Broadway to Tenth Street, just south of Broadway, for approximately one year.

## Discussion

Due to construction of an apartment building located on the northeast corner of Tenth Street and Broadway, and the re-routing of traffic on Tenth Street, staff proposes to relocate the taxi stand currently located on Tenth Street, just north of Broadway to Tenth Street, just south of Broadway. The construction project is estimated to be completed by August of 2015, at which time the taxi stand will revert back to the original location.

**AN ORDINANCE**

amending Chapter 14 of the City Code to temporarily relocate a designated taxi stand on Tenth Street; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 14 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 14-295. Taxi stands designated.

When signs are placed, erected or installed giving notice thereof, the following zones shall be designated as stands for designated vehicles only and no person shall park a vehicle other than a taxi, limousine, bus or STRIPES vehicle between 9:00 p.m. and 2:30 a.m.:

...

*Tenth Street*, west side, between Broadway and Alley A ~~the alleyway just north of Broadway~~.

SECTION 2. This ordinance shall be in full force and effect from and after its passage.
