**Re:** Temporary Sidewalk and Parking Lane Closures Along Portions of the East Side of Seventh Street, North side of Locust Street, and West Side of Eighth Street

### **Executive Summary**

Authorizing Opus Development Company, LLC to temporarily close portions of sidewalk and parking lanes along the east side of Seventh Street, the north side of Locust Street, and the west side of Eighth Street; and the alley connecting Seventh and Eighth streets, between Locust and Cherry streets, for the construction of an apartment building at 127 S Eighth Street.

### Discussion

To facilitate the construction of an apartment building to be located at 127 S. Eighth Street, Opus Development Company, LLC is seeking permission to temporarily close portions of sidewalk and parking lanes between Locust and Cherry streets, and between Seventh and Eighth streets (see attached diagrams). This includes portions of sidewalk and parking lanes on the north side of Locust Street, the east side of Seventh Street, and the west side of Eighth Street. Additionally, the alley connecting Seventh and Eighth streets, between Locust and Cherry streets, will be closed for short durations. The closure is scheduled through July 31, 2015. Pedestrians will be rerouted by signs to utilize the sidewalks on the opposite side of the street.

On behalf of Opus Development Company, LLC, Crockett Engineering has contacted the business owners in the area (see attached letters). Staff has reviewed the attached traffic control plan, and has no issues with their request. Opus Development Company, LLC shall be responsible for all signs and barricades necessary for the protection and convenience of the general public, and shall be responsible for notifications to the media and emergency personnel.

### **Fiscal Impact**

Short-Term Impact: Although the closures will result in meter spaces being temporarily removed from service, the contractor for the project will be required to lease meter bags for the spaces resulting in no lost revenue.

#### A RESOLUTION

authorizing the temporary closure of portions of sidewalks and parking lanes along the east side of Seventh Street, the north side of Locust Street and the west side of Eighth Street, and the temporary closure of the alley between Seventh Street and Eighth Street, to facilitate construction activities at 127 S. Eighth Street.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes Opus Development Company, LLC to temporarily close portions of sidewalks and parking lanes along the east side of Seventh Street, the north side of Locust Street and the west side of Eighth Street, and the temporary closure of the alley between Seventh Street and Eighth Street, as shown on "Exhibit A," from July 7, 2014 to July 31, 2015 to facilitate construction activities at 127 S. Eighth Street.

SECTION 2. Opus Development Company, LLC shall close portions of the sidewalks, parking lanes and alley only in accordance with the closure plan submitted and approved by the City's Director of Public Works. In the interest of public safety, the Director of Public Works may require additional traffic control measures by notifying Opus Development Company, LLC, in writing, of such requirements. Opus Development Company, LLC shall be responsible for all signs and barricades necessary for the protection and convenience of the general public and shall be responsible for the repair of the sidewalks, parking lanes and alley due to any damage caused by the construction activity. Opus Development Company, LLC shall be responsible for notifications to the media and emergency personnel.

SECTION 3. Opus Development Company, LLC shall proceed with construction activities which require the sidewalks, parking lanes and alley closures without unnecessary delay so as to minimize disruption to the public. Failure to proceed without unnecessary delay may result in the revocation of the sidewalks, parking lanes and alley closure permit by the City Council.




