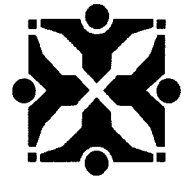

## Executive Summary

The Share the Light program began in 2001 as a way for residents to contribute to City of Columbia projects through their utility bill on a one-time or monthly basis. As of June 2014, almost \$209,000 has been raised for six areas of city programming. Staff is requesting appropriation of funds for use by the Columbia Fire Department and Columbia Police Department.

## Discussion

The Share the Light program allows Columbia residents to contribute to one or more of six areas of city programming that extend beyond basic services. The six areas are community arts programming, community beautification, youth recreation scholarships, public health, fire prevention and education, and crime prevention. Since Share the Light started, \$175,431 has been appropriated (including this request) throughout all six program components.

Staff is asking that \$2,400 in Share the Light funds be appropriated for the following purposes:

1. Columbia Fire Department, \$650. The CFD will use these funds for the purchase of smoke alarms and carbon monoxide alarms. The smoke alarms and carbon monoxide alarms will be distributed by CFD to low income residents in need of an alarm.
2. Columbia Police Department, \$1,750. The CPD will use these funds as follows: \$500 for a Youth Academy (crime education awareness and prevention) to purchase supplies such as shirts, meals/snacks, and incidentals; and \$1,250 for the CPD Explorer/Cadet Program to purchase uniforms and equipment.

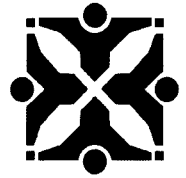
## Fiscal Impact

### **AN ORDINANCE**

appropriating funds for Share the Light Program; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The sum of \$650.00 is hereby appropriated from the Share the Light Utility Charges Fire Prevention Account No. 753-8500-480.50-45 DFPREV to the Fire Department Public Education, Instruments & Apparatus Account No. 110-2341-513.14-70 for the purchase of smoke alarms and carbon monoxide alarms to be distributed to low income residents.

SECTION 2. The sum of \$1,750.00 is hereby appropriated from the Share the Light Utility Charges Police Account No. 753-8500-480.50-46 DCPREV to the Columbia Police Department Miscellaneous Account No. 110-2110-510.13-95 EYTHAC for the purchase of supplies, uniforms and equipment for the Youth Academy and CPD Explorer/Cadet programs.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
