Executive Summary

An ordinance authorizing the City Manager to sign an agreement between the City of Columbia and the Curators of the University of Missouri for medical director services and back-up physician services in the amount of \$112,800.00 effective September 1, 2014 through August 31, 2015.

Discussion

This agreement allows the Department of Public Health and Human Services to have a physician who maintains a collaborative practice agreement with registered professional nurses and advance practice nurses. The medical director also provides medical consultation and guidance for departmental programs.

AN ORDINANCE

authorizing an agreement with The Curators of the University of Missouri, on behalf of the Department of Family and Community Medicine, for medical director services; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to execute an agreement with The Curators of the University of Missouri, on behalf of the Department of Family and Community Medicine, for medical director services for the period of September 1, 2014 through August 31, 2015. The form and content of the agreement shall be substantially in the same form as set forth in "Exhibit A" attached hereto.

SECTION 2. This ordinance shall be in full force and effect from and after its passage.

AGREEMENT

This agreement is entered into on this _____ day of _____, 2014, by and between The Curators of the University of Missouri, a public corporation of the State of Missouri, on behalf of its Department of Family and Community Medicine, at its Columbia Campus (hereinafter referred to as "University") and the City of Columbia, Missouri, a municipal corporation (hereinafter referred to as "City").

WITNESSETH:

WHEREAS, City has need for a physician to provide the following services:

- A. Maintaining a collaborative practice with the Department of Public Health and Human Services Advanced Practice Nurses.
- B. Medical consultation or referral for patients receiving services at the Department of Public Health and Human Services.
- C. Medical consultation with the Department of Public Health and Human Services administration regarding public health issues, program development, etc.
- D. Review and authorization of medical protocols for the Department of Public Health and Human Services clinic services.
- E. Maintaining a collaborative practice agreement with the Department of Public Health and Human Services registered nurses to allow delegation of medical acts required for provision of population based services.
- F. Representation on the Child Fatality Review Panel as the public health representative.
- G. Participation when appropriate in other health related community efforts, such as the Boone County Report Card.

WHEREAS, University is able and willing to provide a physician consultant on a part-time basis to City.

NOW, THEREFORE, for and in consideration of the individual and mutual promises of the parties hereinafter set forth, it is agreed by and between the parties hereto as follows:

1. <u>TERM OF AGREEMENT</u>: This agreement shall become effective on the 1st day of September, 2014 and extend to the 31st day of August, 2015.

2. <u>OBLIGATIONS OF CITY</u>: City will:

a. Provide the facilities and equipment needed at the Department of Public Health and Human Services clinical area/facility.

b. Arrange for the scheduling of patients.

c. On receipt of billing from University, pay to University monthly payments in the amount of Nine Thousand Four Hundred Dollars (\$9,400.00).

3. <u>OBLIGATIONS OF UNIVERSITY</u>: University will:

a. Arrange for Deborah Howenstine, M.D., a member of the Faculty of the Department of Family and Community Medicine, to provide twenty (20) hours per week of clinical and administrative services as described herein; provided that Dr. Howenstine may be absent for up to six (6) weeks and during such absence services will provided as set forth in subparagraph 3(d).

b. Provide Professional Liability Coverage for Deborah Howenstine, M.D. while performing these services.

c. Bill City on a monthly basis for the services under this agreement.

d. The parties agree that University will provide backup coverage for absences of Dr. Howenstine in the form of on-call availability by one of three physicians (Erik Lindbloom, MD, MSPH, Melinda Hecker, M.D., Dan Vinson, MD, MSPH). University will provide Professional Liability Coverage for these physicians while performing these services by the University. City will pay University at a rate of Two Hundred Dollars (\$200.00) per day for backup coverage.
