Executive Summary

A request by P1316, LLC (owner) to vacate utility and drainage easements on Lots 4-18 and the public rights-of-way for Kentsfield Lane and Bretona Circle as shown on the final plat of Discovery Park Subdivision, Plat 2A. (Case #14-115)

Discussion

This is a request to vacate unimproved water, sewer, and drainage easements located on Lots 4-18 of Discovery Park Subdivision Plat 2A and the unimproved public rights-of-way of Kentsfield Lane and Bertona Circle within the same development. The requested vacations are the result of the developer's desire to revise the subdivision's lot layout and refine the development program for the site's acreage.

Associated with this request are three related cases that will be presented to the Council for consideration at their August 14 meeting. The first is a 10-lot replat (Case #14-117) of the subject acreage which will dedicate new easements (to replace those vacated) and enlarged right-of-way for Philips Farm Road. The second is a C-P development plan (Case #14-116) that proposes office/medical building development at the southwest corner of Philips Farm Road and Ponderosa Street. And the third request is a rezoning and C-P development plan approval (Case #14-120) involving Lots 4-7 of the proposed replat.

City staff and external utility providers have reviewed the requested vacations and find them to acceptable. No utilities have been installed in the existing easements and the rights-of-way to be vacated were for roadways not under construction and no longer needed based on the pending C-P development plans.

A locator map and copy of the exhibit showing the location of the easements and rights-of-way to be vacated are attached.

AN ORDINANCE




