# **Executive Summary**

The FEMA grant application submitted in December 2013 has been awarded to purchase 56 SCBA (Self Contained Breathing Apparatus) in order to be in compliance with the new national standards. This request is for acceptance of the federal funds and to appropriate the funds.

#### Discussion

The Assistance to Firefighters Grant program has been operational since 2001 as a nationally competitive application process administered by FEMA. The Columbia Fire Department has been chosen for seven grant awards in that period.

The current grant guidance document FEMA has published lists high to low award priorities with the highest priority going to out of date self contained breathing apparatus (SCBA's). This priority assignment dovetails with the Fire Department current need of replacing airpacks in order to be in compliance of the new national standards. The grant project total approved by FEMA is \$482,918 with the federal share of 90% coming to \$434,627.

The local match: The local share of 10% amounts to \$48,291, the match will come from the 2014 supplemental that was approved to replace air packs.

#### **Fiscal Impact**

Short-Term Impact: The FY15 budget would increase by \$434,627 in order to purchase the SCBA. Long-Term Impact: The period of performance is one year.
