Executive Summary

Approval and appropriation of funds will allow more education on fire safety to the public.

Discussion

Donation of \$1,000 from Common Voices will be utilized for Fire Factor; modifications to side by side trailer, purchase prizes for the face off and contribute towards the shirts for the event.

Donation of \$1,000 from Wal-Mart will be used to purchase two flat screen tv's, wall mounts and any extra monies will go toward the purchase of fire prevention videos. Both TV's will be used as tools in teaching fire/burn prevention and child car seat safety.

Donation of \$526 from FM Global - \$450 to purchase Fire Prevention DVD series for PR/Public Education and \$76 to purchase Audio CD's to be played at PR/Public Education events by Patches and Pumper.


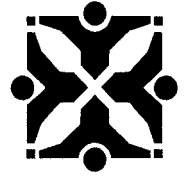

AN ORDINANCE

accepting donations from Common Voices, Wal-Mart and FM Global to be used by the Fire Department for public education and fire safety programs; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby accepts a \$1,000.00 donation from Common Voices, a \$1,000.00 donation from Wal-Mart and a \$526.00 donation from FM Global to be used by the Fire Department for public education and fire safety programs.

SECTION 2. The sum of \$2,526.00 is hereby appropriated from Account No. 753-8500-480.53-23 in the following sums to the following accounts:
