Executive Summary

Amending Chapter 14 of the City Code to prohibit parking on both sides of Scott Boulevard, from Wales Drive to Route K; and on both sides of Wales Drive, for the entire length of the street.

Discussion

The Columbia Police Department has notified staff of issues with occasional parking along Broadway and Wales Drive (see attached location map). Wales Drive is located on the north side at the corner of Broadway and Scott Boulevard. These roadways are generally multi-lane and do not have adequate space for parking. Staff proposes to amend Section 14-324 of the City Code to prohibit parking on Scott Boulevard, from Wales Drive to Route K, and on the entire length of Wales Drive. Ordinance 14-324 currently prohibits parking along Broadway in this area.
