## **Executive Summary**

Setting a public hearing for November 17, 2014, for the construction of sidewalk improvements on the east side of Bernadette Drive from Ash Street to Tiger Lane, as shown on the attached location map. An interested parties (IP) meeting was held September 23, 2014, and the concept cost estimate for the project is approximately \$66,000.

#### Discussion

The Water and Light department is funding the Bernadette Drive sidewalk project with 2010 Enterprise Revenue funds in conjunction with an expansion project at the West Ash Pumping Station. The sidewalk project consists of constructing approximately 650 linear feet of sidewalk on the east side of Bernadette Drive from Ash Street to Tiger Lane. The concept includes a six-foot-wide sidewalk at the back of curb, and reconstruction of two sidewalk ramps to meet ADA requirements. This project is entirely on City-owned property and no temporary or permanent easements will be needed for the construction of the project.

An IP meeting was held on September 23, 2014. One (1) person signed in and was supportive of the project. No official comments were received.

### Fiscal Impact

Short-Term Impact: The construction concept cost estimate for this project is \$66,000, and will be funded by 2010 Enterprise Revenue Funds.

Long-Term Impact: The additional cost of maintenance for this sidewalk is approximately \$325 per year.

#### **A RESOLUTION**

declaring the necessity for construction of sidewalk improvements along the east side of Bernadette Drive between Ash Street and Tiger Lane; stating the nature of and the estimate of the cost of the improvement; providing for payment for the improvement; providing for compliance with the prevailing wage law; and setting a public hearing.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems the construction of a six-foot wide sidewalk along the east side of Bernadette Drive between Ash Street and Tiger Lane and the reconstruction of two sidewalk ramps to meet ADA requirements, and other miscellaneous work, all in accordance with City of Columbia Street and Storm Sewer Specifications and Standards, necessary to the welfare and improvement of the City.

SECTION 2. The nature and scope of the improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvement.

SECTION 3. The estimated cost of this improvement is \$66,000.00.

SECTION 4. Payment for this improvement shall be made from 2010 Enterprise Revenue Funds and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.

SECTION 6. A public hearing in respect to this improvement will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on November 17, 2014. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.






