Executive Summary

If approved, the fee schedule for voluntary annexation or annexation agreement petitions will be revised to require the payment of public hearing advertising fees.

Discussion

Chapter 20 of the City Code includes current fees changed by the Planning and Zoning Division for services it renders. In general, these fees include charges that offset the administrative costs of processing applications and the costs for non-administrative services such as public advertising and recording of documents.

Following the adoption of the revised FY 2015 Fee Schedule it was brought to staff's attention that advertising fees associated with annexation petitions were not identified as being required with such applications. Currently the advertising fees associated with these types of applications are paid from either the general Community Development Department or City Council budgets.

The attached text change would eliminate this omission and require that advertising fees for annexation petitions be paid as part of the application process. This change would ensure that annexation petitions are treated equally with all other applications that require public advertising. It is recommended that such fee change not become effective until January 1, 2015 to allow for proper notification of affect stakeholders.

Fiscal Impact

Short-Term Impact: Positive short-term impacts will be incurred by the Community Development Department and the City Council by no longer incurring non-budgeted expenses associated with advertising fees for annexation petitions. An average savings of approximately \$117 and \$165 per application, respectively, will be seen by the Community Development Department and the City Council.

Long-Term Impact: No long-term costs will be incurred by the impacted departments.
