Executive Summary

Council passed Ordinance 022226 on September 15, 2014 authorizing the acquisition of easements to construct the Manor Drive, from Rollins Road to West Broadway, sidewalk improvement project. This ordinance contained incorrect easement descriptions for the project; therefore, staff is requesting Council repeal Ordinance 022226 and pass a new ordinance with the correct easement descriptions.

Discussion

The Manor Drive, from Rollins Road to West Broadway, sidewalk improvement project is part of the Non-Motorized Transportation (GetAbout) program. The project includes construction of a 6-ft wide sidewalk at the back of the curb on the east side of Manor Drive, from Rollins Road to Manor Court, then crossing to the west side of Manor Drive and continuing toward West Broadway, finally tying into existing sidewalk near Broadway. The concept includes approximately 2,550 linear feet of sidewalk and reconstruction of 26 driveways to meet ADA requirements.

The public hearing for this project was held on July 21, 2014, and Ordinance 022226 was passed on September 15, 2014 authorizing the acquisition of easements. Due to the ordinance containing incorrect easement description information, staff is requesting that Council repeal Ordinance 022226 and pass a new ordinance with correct easement descriptions.

Fiscal Impact

Short-Term Impact: The current project cost estimate for this project is \$369,000, and is being funded from the Non-Motorized Transportation (GetAbout) grant.

Long-Term Impact: Long-term maintenance is the responsibility of the adjoining landowner.

AN ORDINANCE

repealing Ordinance No. 022226; declaring the need to acquire easements for construction of sidewalk improvements along Manor Drive, from Rollins Road to West Broadway; authorizing acquisition by negotiation or, if necessary, by condemnation; authorizing the City Manager to obtain and execute all instruments necessary for acquisition of such land; and fixing the time when this ordinance shall become effective.

WHEREAS, Ordinance No. 022226, passed by the Council on September 15, 2014, declared the necessity to acquire easements for construction of sidewalk improvements along Manor Drive, from Rollins Road to West Broadway; and

WHEREAS, Ordinance No. 022226 contained incorrect easement legal descriptions for the sidewalk improvement project and it is in the best interest of the City to repeal Ordinance No. 022226 and enact this ordinance containing correct legal descriptions in lieu thereof: and

WHEREAS, the Constitution and Statutes of the State of Missouri and the Home Rule Charter for the City of Columbia, Missouri, authorize the City Council to exercise the power of eminent domain, within or without the City, and among other things, to acquire, and maintain any property, real or personal within or without the City for all public uses or purposes, and to acquire, receive and hold any estate or interest in any such property; and

WHEREAS, the Council deems it necessary for the welfare and improvement of the City and in the public interest that certain private property be acquired by negotiation or by condemnation for public improvement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Ordinance No. 022226, passed by the Council on September 15, 2014, is hereby repealed in its entirety.

SECTION 2. The City Council hereby declares the need to acquire easements for construction of sidewalk improvements along Manor Drive, from Rollins Road to West Broadway, described as follows:


