Executive Summary

A council bill has been prepared to call the municipal election for April 7, 2015.

Discussion

Under the City Charter, a regular election for municipal officials is held every April. In April 2015, the election will be for council members for Wards 2 and 6. Each candidate for the Wards 2 and 6 positions must file a nominating petition signed by at least 50 but no more than 75 registered voters entitled to vote for the candidate. Nominating petitions must be filed no later than January 13, 2015.

Fiscal Impact

Short-Term Impact: Fiscal impact unknown at this time. The cost is based on the various entities who have placed an item on the ballot for any particular election. The City's proportionate share for the April 2014 election was \$22,848.60, which was an election to fill the positions of Wards 1 and 5.

The City's proportionate share of the April 2013 election was \$58,649.60, which was a City-wide election to fill the positions of Mayor and Wards 3 and 4.
