Executive Summary

Appropriating \$5,000.00 awarded to the Convention & Visitors Bureau to offset expenses for travel writers to attend the True/False Film Festival March 5-8, 2015.

Discussion

In March 2015, Columbia will be hosting the 11th annual True/False Film Fest. This festival has a glowing reputation for being one of the best in the world for documentary filmmakers.

Each year, the Convention and Visitors Bureau provides transportation, lodging, meals and festival passes to a select group of media. We have confirmed nine film, travel and music writers coming from as far away as London and two travel writers from New York. The coverage these journalists provide will benefit the festival, Columbia and the state, with a reach that will find international audiences. We have received funding in the amount of \$5.000.00 from the Missouri Division of Tourism to help defray travel and lodging costs of these travel writers.
