## Executive Summary

Public Works staff is requesting to amend the FY 2015 Annual Budget to reassign a Maintenance Assistant to a Parking Meter Repair Assistant in the Parking Utility. This reassignment is budget neutral.

## Discussion

In 2015, the parking meter collection and enforcement hours were amended to begin at 9:00 AM and end at 7:00 PM, while collection begins at 8:00 AM in the parking garages. The Parking Utility currently has one Parking Meter Repair Assistant position; however, due to the extended period of time that the parking meters are enforced, the Parking Utility is needing the skillset of a second Parking Meter Repair Assistant. Staff is requesting to reassign a vacant Maintenance Assistant position within the Parking Utility, to a Parking Meter Repair Assistant. Both positions are a Grade 6; therefore, this reassignment is budget neutral.



**AN ORDINANCE**

amending the FY 2015 Annual Budget by adding and deleting positions in the Public Works Department – Parking Utility Division; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The FY 2015 Annual Budget adopted by Ordinance No. 022207 is amended by adding the following position to the Public Works Department – Parking Utility Division authorized personnel:

1.00 FTE 3018 Parking Meter Repair Assistant - 773 Grade A6 OT Non-Exempt

SECTION 2. The FY 2015 Annual Budget is further amended by deleting the following position from the Public Works Department – Parking Utility Division authorized personnel:

1.00 FTE 2397 Maintenance Assistant – 773 Grade A6 OT Non-Exempt

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
