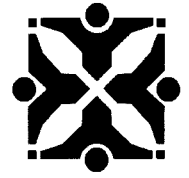

Staff has prepared for Council consideration a resolution granting a waiver of the open container ordinance for the Marcassin Drive Neighborhood Block Party.

Discussion

Mike Seripico, is requesting a waiver of the open container ordinance on Marcassin Drive, from Greengate Lane to Old Hawthorne, on July 18, 2015 from 12:00 p.m. until 11:00 p.m., to hold a neighborhood block party. There will be no alcohol sales or distribution; neighbors may pass through street with open container while attending others' properties.

The City Event Committee has reviewed the request and approved the closure of Marcassin Drive, from Greengate to Old Hawthorne, on July 18, 2015, for this event.

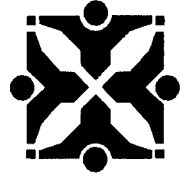

A RESOLUTION

authorizing the temporary closure of a portion of Marcassin Drive between Greengate Lane and Old Hawthorne Drive; granting a temporary waiver from the requirements of Section 16-185 of the City Code to allow possession and consumption of alcoholic beverages for the Marcassin Drive Neighborhood Block Party event.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes the temporary closure of a portion of Marcassin Drive between Greengate Lane and Old Hawthorne Drive between the hours of 12:00 p.m. and 11:00 p.m. on July 18, 2015 for the Marcassin Drive Neighborhood Block Party event.

SECTION 2. The City Council hereby grants a temporary waiver from the requirements of Section 16-185 of the City Code so that the possession of an open container of alcohol and consumption of an alcoholic beverage shall be allowed during the Marcassin Drive Neighborhood Block Party event on July 18, 2015 from 12:00 p.m. until 11:00 p.m.
