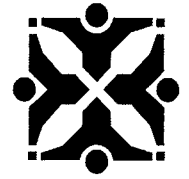

Executive Summary

Staff has prepared an ordinance to formally declare and approve the results of the Waterworks and Electric System Revenue Bonds ballot question held on April 7, 2015.

Discussion

The ordinance provides documentation of compliance with the statutory requirements for a valid election on the Waterworks and Electric System Revenue Bonds and affirms the passage of the measure by the voters. This item is simply a record-keeping matter to formally establish all requirements were met to authorize the issuance of the bonds. The legislative actions necessary to authorize sale and issuance of the bonds will be brought forward to council for approval as funds are needed for project construction.

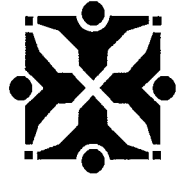

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. It is hereby found and declared that the vote at the election held in the City of Columbia, Missouri, on Tuesday, April 7, 2015, on the following question:

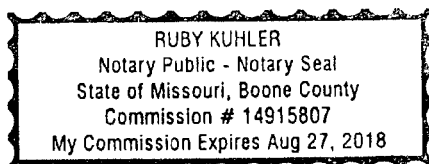
