#### **Executive Summary**

Staff has prepared for Council consideration a council bill to accept and appropriate funds in the amount of \$30,000 from the Youth Community Coalition (YC2).

#### Discussion

The Youth Community Coalition Grant provides funding to the Columbia Police Department for the performance of environmental strategies which reduce the availability of alcohol, change consequences of underage alcohol use, and increase the perception of risks associated with underage alcohol use.

Funds are to be used for training, equipment, and overtime wages for officers conducting party patrols, shoulder taps, compliance checks; and stipends for youth involved in the completion of the above strategies.
