# **Executive Summary**

An ordinance authorizing the City Manager to sign Amendment #02 to Contract #ERS04515095 for WIC Local Agency Nutrition Services between the City of Columbia and the Missouri Department of Health and Senior Services in the amount of \$1,550; appropriating funds. The contract period is October 1, 2014 through September 30, 2015.
