Executive Summary

Authorizing an amendment to Chapter 14 of the City Code to prohibit parking along a portion of Fay Street at all times. Staff recommendation is to restrict parking on the east side of the street from Hinkson Avenue to a point 250 feet north thereof.

Discussion

In January of 2015, staff received a request to address parking issues along Fay Street just north of Hinkson Avenue, due to access issues while vehicles are parked on the street. Fay Street is approximately 21 to 22 feet wide in this area and there are currently no parking restrictions on the street. Staff contacted the Fire Department regarding access, and their field inspection concluded that if vehicles are parked in front of the Woodruff Switzer building (Historic Mule Barn), it would compromise emergency access to that building (see attached e-mail).

In February of 2015, staff sent a letter to property owners along Fay Street, from Hinkson Avenue to the COLT Railroad, seeking feedback concerning a possible parking prohibition on the street. Following is a summary of the responses received from property owners. The letter from staff and responses from the property owners are attached.

- 5 do not restrict parking;
- 1 restrict parking on both sides from Hinkson Avenue to the COLT Railroad;
- 3 restrict parking on the east side from Hinkson Avenue to the COLT Railroad;
- 1 restrict parking on a portion of the east side from Hinkson Avenue to the COLT Railroad;
- 2 restrict parking on a portion of both sides from Hinkson Avenue to the COLT Railroad;
- 1 e-mail response received is from the same address as a survey response.

Due to the responses received, staff recommends restricting parking on the east side of Fay Street from Hinkson Avenue to a point 250 feet north thereof; and to address the Fire Department's concern, staff has painted a 15 ft section of curb on on each side of an FDC fire connection, on the west side of Fay Street.



Chief's.

I was asked by Chief Warren to evaluate the access situation on Fay street as concerned above.

It is my opinion that due to the size of the street and our apparatus that we would not be able to safely operate the outriggers on our aerial device such as Ladder One. If possible, I feel it would be best to remove the parking spaces on the West side of the road directly in front of the Wodruff Switzer building. This would allow our apparatus better access in an emergency.

In addition restricting parking in front of the building will also open the access to the FDC located in front of the building. As you can see in the picture below with the current parking gaining access to the FDC could be troublesome.

This letter is to provide information that the Public Works Department is considering recommending that City Council pursue prohibiting parking along a portion of Fay Street from Hinkson Avenue to the COLT Railroad. We are asking for owners and residents along Fay Street in this area to provide staff with comments regarding this proposed restriction.

This request for comments has been initiated due to citizen contact indicating concerns with limited ability to drive along Fay Street just north of Hinkson Avenue with parking present of the street.

There is no current parking restriction per city ordinance on Fay Street from Hinkson Avenue to the COLT Railroad. There is a loading zone on the west side of Fay Street from Hinkson Avenue to a point about 70 feet north thereof.

Based on Public Works staff evaluation of the street and with consultation from Fire Department personnel, staff believes that a parking prohibition along a portion of the east or west side of Fay Street from Hinkson Avenue to the COLT Railroad at all times may be appropriate. We are seeking input regarding parking along the street.

Mr. Valleroy,

I received the letter from Richard Stone regarding the proposal to prohibit parking along Fay Street from Hinkson Ave. I attempted to fill out the on-line survey twice but have not been able to access the resource.

I am opposed to the recommendation as this will cause further congestion with parking in the surrounding areas. I am the landlord at 504 Fay Street (Logboat Brewing Co) and was required to install a sidewalk on the east side of Fay Street during construction. Although that was costly and likely satisfies the appropriate code it does make that lane narrow when cars park along the west side of the road. The newly constructed sidewalk is rarely used and in fact leads directly into a telephone pole. My concern is that removing those spots will cause people to park illegally at other businesses or even in private parking spaces, which could lead to additional towing complaints. I do not know the motivation behind the recommendation or if there have been complaints but I am certainly interested in being a part of proposed solutions. I would not be surprised if this proposal was adopted that you would receive far more complaints regarding parking.
