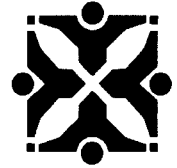

Executive Summary

Staff has prepared for Council consideration a resolution granting a waiver of the open container ordinance for a 9th Street Summerfest concert, held outside the Blue Note on 9th Street.

Discussion

Matt Gerding, The Blue Note, is requesting a waiver of the open container ordinance on 9th Street, from Walnut to Broadway, on September 10, 2015 from 6:30 p.m. until 11:00 p.m., to hold a SummerFest concert.

The City Event Committee has reviewed and approved the associated street closure for the proposed area with conditions to ensure safety for event-goers and the public. Mr. Gerding and the Blue Note has met all requirements set forth in Chapter 24 of the City Code as it relates to special event permits.

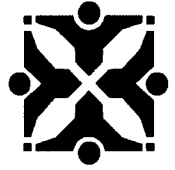

A RESOLUTION

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby grants a temporary waiver from the requirements of Section 16-185 of the City Code so that the possession of an open container of alcohol and consumption of an alcoholic beverage shall be allowed from 6:30 p.m. until 11:00 p.m. for the area along a portion of Ninth Street between Walnut Street and Broadway during The Blue Note Ninth Street SummerFest concert on September 10, 2015.

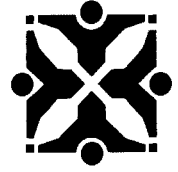
