Re: Parking Permit Rate Increase for Parking Facilities, Surface Lots and Meter Hoods

### **Executive Summary**

Staff is proposing to amend Chapter 14 of the City Code to increase parking permit fees for non-designated unmetered parking spaces located in municipal surface lots and parking facilities. Additionally, staff is recommending an increase in parking meter hood fees.

#### Discussion

Effective January 1, 2016, staff recommends increasing unmetered parking permit fees for all parking spaces in municipal surface lots as follows:

- Monthly from \$65.00 to \$70.00
- Quarterly from \$190.00 to \$205
- Yearly from \$715.00 to \$770

Increase parking permit fees for all uncovered parking spaces in municipal parking structures as follows:

- Monthly from \$65 to \$75.00
- Quarterly from \$190 to \$220.00
- Yearly from \$715 to \$825.00

Increase parking meter hood fees as follows:

- Daily from \$8 to \$10
- Monthly from \$150 to \$200
- Annually from \$1,600 to \$2,000

# Fiscal Impact

Short-Term Impact: Parking permit fees for parking spaces in surface lots will increase \$5/month, \$15/quarter and \$55/annually. Parking permit fees for uncovered parking spaces in parking facilities will increase \$10/month, \$30/quarter and \$110/annually. Parking meter hoods will increase \$2/day, \$50/month and \$400/annually.

Long-Term Impact: Staff estimates an additional \$37,785 increase in annual revenue for parking permit fees.

#### **AN ORDINANCE**

amending Chapter 14 of the City Code as it relates to parking fees for unmetered off-street municipal parking lots and facilities and parking meter hoods; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 14 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 14-393. Parking fees for unmetered off-street facilities.

(a) For a parking permit for parking in a nondesignated unmetered parking space in the municipal parking garage located at the northeast corner of Eighth and Cherry Streets, the following rates are hereby established.

Sec. 14-424. Same—Special hoods.

- (a) The city manager may authorize the issuance of marked parking meter hoods to the following persons at the rates stated herein, which shall be in lieu of meter charges:
  - (1) Contractors and service agencies, who exhibit a need to park vehicles at specific meter locations in order to perform their work—Eight dollars (\$8.00) Ten dollars (\$10.00) per day.
  - (2) Private utilities companies, for the parking of service vehicles identifiable as such by color or signs—Eight dollars (\$8.00) Ten dollars (\$10.00) per day.
  - (3) Churches and any business that establishes a business-related need for the issuance of such hoods—<u>Eight dollars (\$8.00)</u> <u>Ten dollars (\$10.00)</u> per day.
  - (4) Handicapped persons, who establish an employment need for the issuance of such hood and who either are nonambulatory or who present a physician's certificate of need with respect to their handicap—Two dollars and fifty cents (\$2.50) per day or fifty dollars (\$50.00) per month.
- (b) The city manager may, by regulations, impose conditions and limitations upon the issuance and use of such hoods. The city manager may also withdraw or revoke hoods issued hereunder, provided that any prepayments are refunded pro rata.
- (c) The city manager shall have the authority to issue annual and or monthly parking hoods to service agencies, private utility companies, theater operators and funeral home operators who establish a reasonably definite basis of estimating their annual use of such hoods. The minimum fee for issuance of annual hoods shall be sixty cents (\$0.60) per estimated hour of usage, provided that the minimum annual hood fee shall be one thousand six hundred dollars (\$1,600.00) two thousand dollars (\$2,000.00) payable in advance. The monthly fee shall be one hundred fifty dollars (\$150.00) two hundred dollars (\$200.00).
