Executive Summary

Pursuant to section 19-25(a) the City Manager has the authority to recommend to the City Council the recognition of appropriate representative units of employees with a mutually acceptable community of interest for the purpose of meeting, conferring, and discussing salaries and other conditions of employment which are mutually agreed upon as proper subjects for such discussions. This recommendation is made following certified elections or other assurances of interest deemed appropriate by the City Manager and not inconsistent with state legislation.

Discussion

All six police lieutenants desired to organize and requested consideration by the City Manager that the appropriate representative unit with community of interest, would be all Columbia Police Department Lieutenants and submitted affidavits as assurances of interest. The City Manager found that the submitted six notarized affidavits are acceptable assurances of interest to recommend to the City Council that the lieutenants of the Columbia Police Department be recognized as an appropriate bargaining unit of employees, separate from other Columbia Police Department employees as supervisory employees pursuant to section 19-26(9).
