### **Executive Summary**

Approval of the ordinance will result in the vacation of several utility easements that are no longer necessary for public use, and the dedication of new easements for utilities serving the existing development on the subject property.

#### **Discussion**

Engineering Surveys and Services (applicant), on behalf of Boone Hospital Center C/o The Graham Group (owner) is requesting approval to vacate multiple utility easements on property located at the northeast corner of Broadway and William Street, addressed as 1601, 1605, 1701, and 1705 Broadway, and generally known as the Boone Hospital Medical Park. The requested vacations consist of four easements for sewer purposes and one easement for electric purposes.

The easements were previously dedicated during the initial development of the Boone Hospital Medical Park; however, during more recent construction, many of the utilities were relocated to accommodate the construction of new buildings. The utility easements were not vacated at that time (which means they remained in the same location even after the utilities were relocated) and are still currently in effect, precipitating the need for the vacation as portions of the easements are located under existing buildings.

During review of requested vacations, staff determined that additional easement dedications were required on this site for existing utilities. The applicant has submitted the required Grant of Easement for these utility locations, which have been approved by staff, and are included for acceptance by City Council concurrently with the requested vacation of the aforementioned sewer and electric easements.

Staff has reviewed the requested vacations and determined that no active utility currently exists within any of the easements that the applicant seeks to vacate, and supports the request. Locator maps and easement graphics are attached for reference.

vacating sewer and electric easements located on the northeast corner of Broadway and William Street (1601, 1605, 1701 and 1705 Broadway); directing the City Clerk to have a copy of this ordinance recorded; accepting conveyances for sewer purposes; directing the City Clerk to have the conveyances recorded; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:


# 15-180: Boone Hospital Medical Park **Easement Vacation**




