Executive Summary

Staff has prepared for Council consideration a resolution setting a Public Hearing for November 16, 2015 concerning security upgrades to the existing Columbia Police Department Headquarters building.

Discussion

The Columbia Police Department Headquarters building, located at 600 E Walnut St, recently went through a security audit conducted by the Columbia Police Department's Assistant Police Chiefs. During the audit it was determined that there are several deficiencies in security that need to be addressed.

Fiscal Impact

Short-Term Impact: The project is estimated to cost \$175,000 and will be paid from existing funds in the Downtown Police Building Renovation Capital Improvement Project account. Long-Term Impact: No additional costs for years beyond two.

A RESOLUTION

declaring the necessity for construction of security upgrades to the Columbia Police Department building located at 600 E. Walnut Street; stating the nature of and the estimate of the cost of the improvement; providing for payment for the improvement; providing for compliance with the prevailing wage law; and setting a public hearing.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems the construction of security upgrades to the Columbia Police Department building located at 600 E. Walnut Street, necessary to the welfare and improvement of the City.

SECTION 2. The nature and scope of the improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvement.

SECTION 3. The estimated cost of this improvement is \$175,000.00.

SECTION 4. Payment for this improvement shall be made from Downtown Police Building Renovation Capital Improvement Project funds and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.

SECTION 6. A public hearing in respect to this improvement will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on November 16, 2015. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.
