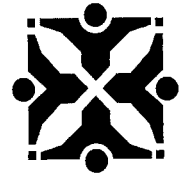

## Executive Summary

Authorizing a bid call through the Purchasing division for construction of sidewalk and stormwater improvements on the east and south sides of Green Meadows Circle, north of Fire Station #7 entrance to Greenbriar Drive, as shown on the attached diagram. A public hearing is being held on November 2, 2015 and an Interested Parties (IP) meeting was held September 22, 2015. The CIP cost estimate for this project is \$75,000.

## Discussion

Green Meadows Circle, located off of Green Meadows Road, is a residential street. The proposed sidewalk project consists of constructing approximately 360 ft of continuous sidewalk on the east and south sides of Green Meadows Circle, which links neighborhoods, schools, churches, workplaces, shopping areas, and health facilities. The design includes a 5-ft wide sidewalk with approximately 8-ft of green space between the sidewalk and the pavement edge. A small portion of the existing asphalt pavement at the corner of Green Meadows Road and Green Meadows Circle will be replaced to repair some drainage issues.

The CIP budget for this project is \$75,000 and will be funded by 0.25% Capital Improvement Sales Tax. A public hearing is being held on November 2, 2015 and an IP meeting was held on September 22, 2015. Construction is planned for Fall of 2015.

## Fiscal Impact

**Short-Term Impact:** The CIP budget for this project is \$75,000 and payment shall be made from 0.25% Capital Improvement Sales Tax.

**Long-Term Impact:** Routine maintenance is estimated at \$300 per year.

### **AN ORDINANCE**

determining it is in the public interest to construct sidewalks on the east and south sides of Green Meadows Circle, north of the Fire Station #7 entrance to Greenbriar Drive, and storm water improvements at the corner of Green Meadows Road and Green Meadows Circle; approving and adopting plans and specifications; determining that the work shall be done by contract; calling for bids through the Purchasing Division; providing for payment for the improvement; authorizing the City Manager to obtain, execute and record all documents necessary for the improvement; providing for compliance with the prevailing wage law and state-mandated construction safety training; and fixing the time when this ordinance shall become effective.

WHEREAS, the City Council adopted a resolution declaring the necessity of constructing sidewalks on the east and south sides of Green Meadows Circle, north of the Fire Station #7 entrance to Greenbriar Drive, and storm water improvements at the corner of Green Meadows Road and Green Meadows Circle; and

WHEREAS, the notice of a public hearing on this project was published in a daily newspaper of general circulation in the city; and

WHEREAS, the City Council has held a public hearing on construction of the improvement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds that the construction of five-foot wide sidewalks on the east and south sides of Green Meadows Circle, north of the Fire Station #7 entrance to Greenbriar Drive, and storm water improvements to include the replacement of the existing asphalt pavement at the corner of Green Meadows Road and Green Meadows Circle, all in accordance with City of Columbia Street and Storm Sewer Specifications and Standards, in the City of Columbia, Missouri, is necessary for the welfare and improvement of the city and that it is in the public interest that such improvements be made.

SECTION 2. The plans and specifications for this improvement, as prepared by the Director of Public Works, are hereby approved.

SECTION 3. The construction of the improvement shall be done by contract in accordance with the plans and specifications, the laws of the State of Missouri, and the Charter and Ordinances of the City of Columbia, Missouri.

SECTION 4. The Purchasing Agent is hereby authorized to call for bids and execute a contract for the improvement.

SECTION 5. Payment for this improvement shall be made from Capital Improvement Sales Tax Funds and such other funds as may be lawfully appropriated.

SECTION 6. The City Manager is authorized to obtain, execute and have recorded all licenses, easements, deeds and any other conveyances or instruments necessary for the City to complete this improvement.

SECTION 7. The contract for the improvement shall provide that not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under the contract. The contractor's bond shall guarantee the faithful performance of the prevailing hourly wage clause in the contract.

SECTION 8. The bid specifications and contract for the improvement shall provide that the contractor and any subcontractor shall provide a ten-hour Occupational Safety and Health Administration construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations) for all employees working on-site. All employees working on the site of the improvement are required to complete the safety program within 60 days of beginning work on the improvement project.

SECTION 9. This ordinance shall be in full force and effect from and after its passage.

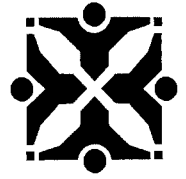

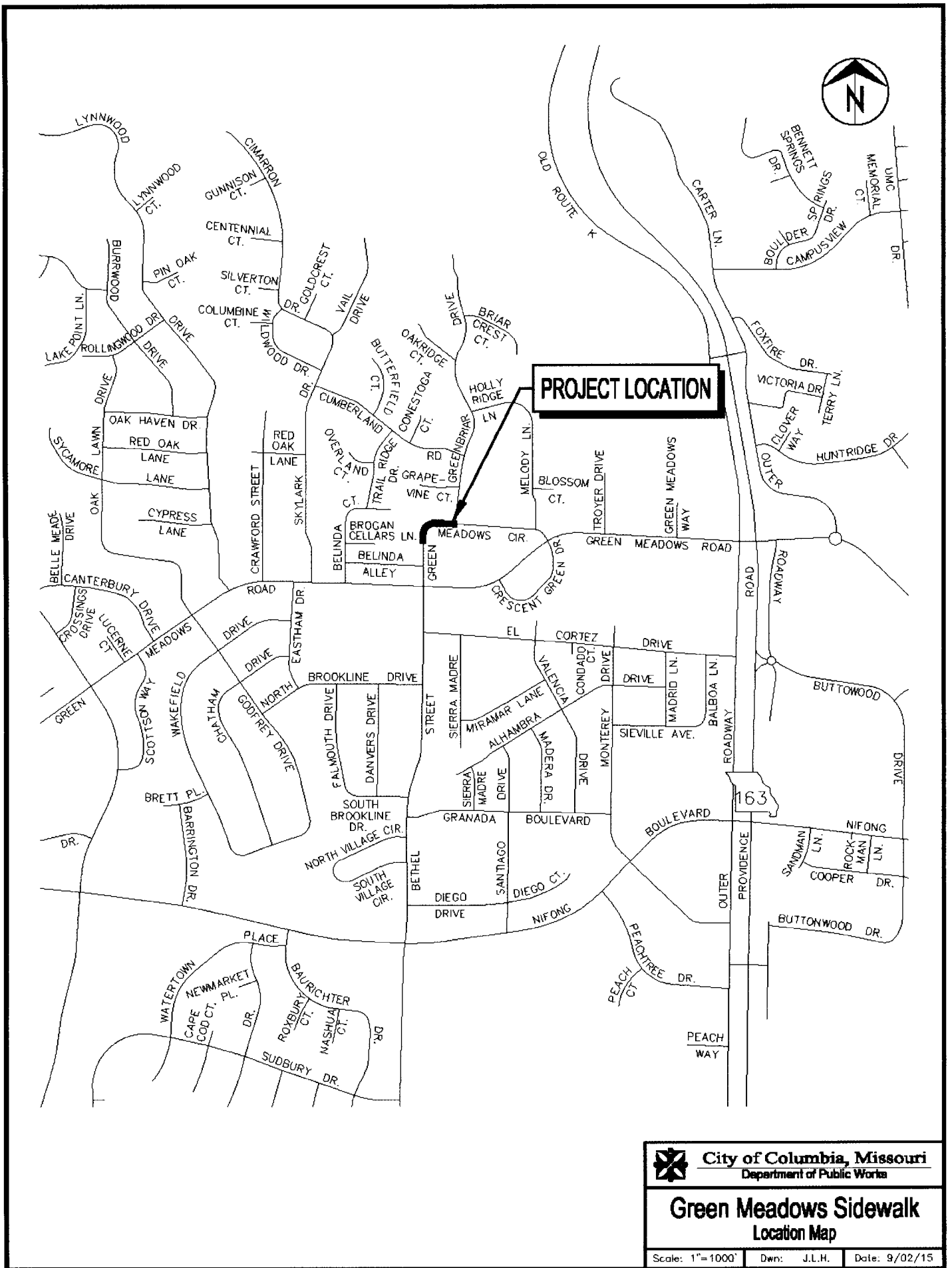

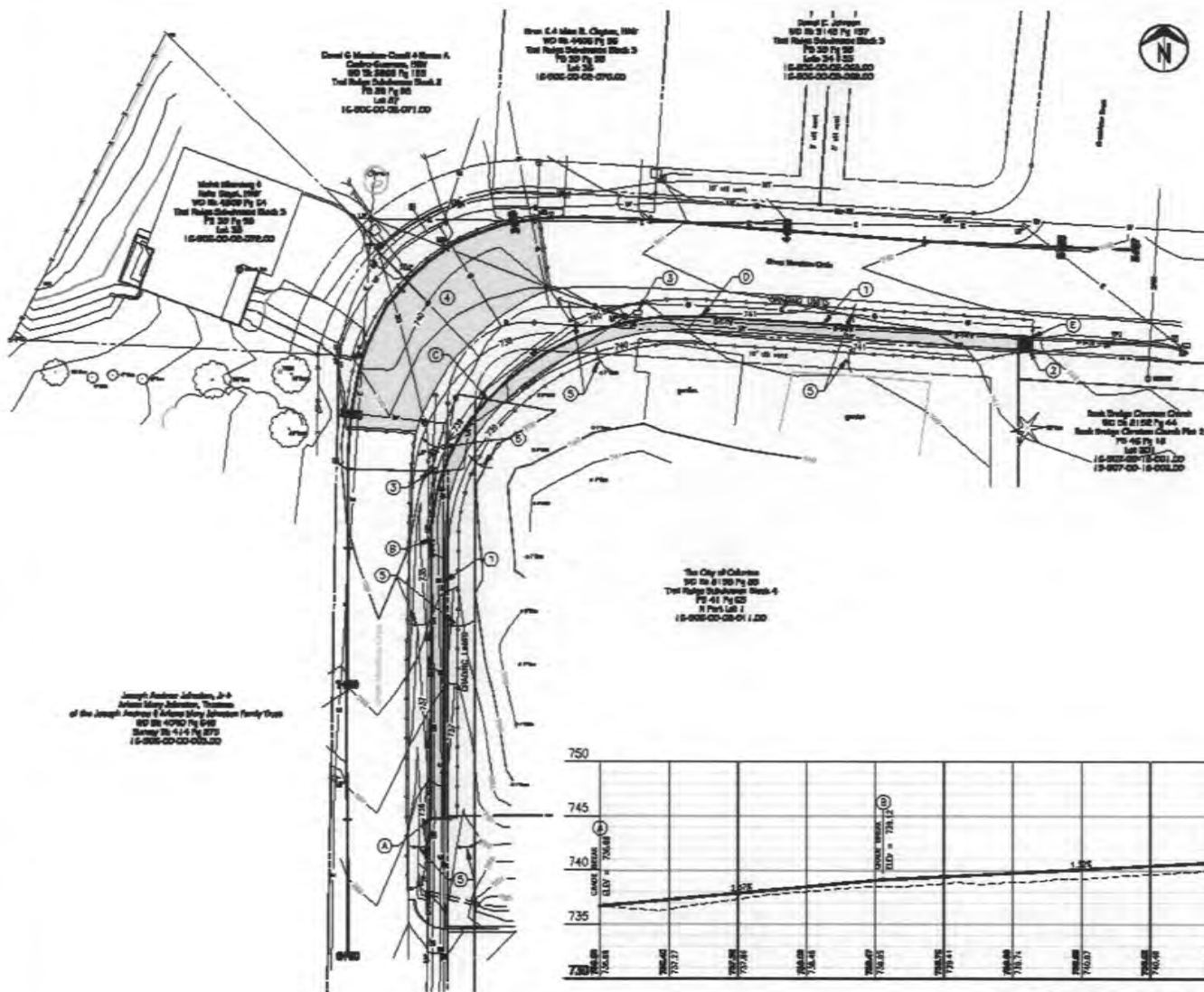

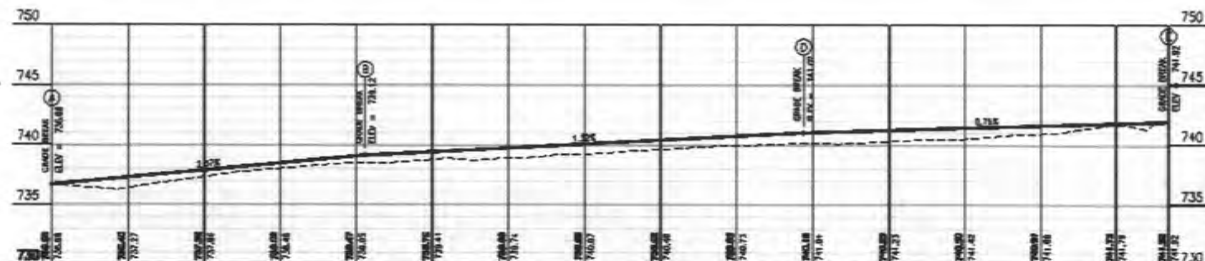

3. COORDINATE UTILITY ADJUSTMENT WITH THE APPROPRIATE COMPANY.
4. REMOVE EXISTING PAVEMENT AND INSTALL 6" PCC PAVEMENT PER PLAN, CROSS SECTIONS AND DETAILS.
5. INSTALL AND MAINTAIN SELF POLICE DURING GRADING OPERATIONS.
