Executive Summary

The Missouri Division of Tourism has awarded the Convention & Visitors Bureau \$5,000 to assist with expenses for travel writers to attend the 2016 True/False Film Fest in March 2016.

Discussion

In March 2016, Columbia will be hosting the annual True/False Film Fest. This festival has an outstanding international reputation for being one of the world's best documentary festivals.

Each year, the Convention and Visitors Bureau provides transportation, lodging, meals and festival passes to a select group of vetted media. Typically, around ten media members who cover general travel, film and music from across the country and an array of high-level media outlets attend the festival. The coverage these journalists provide benefits Columbia, Missouri and the festival with a reach that finds regional, national and international audiences. The CVB has been awarded funding in the amount of \$5,000.00 from the Missouri Division of Tourism to assist in defraying travel and lodging costs for these writers.
