Re: April 2015 Municipal Election

### **Executive Summary**

A council bill has been prepared to call the municipal election for April 5, 2016.

#### Discussion

Under the City Charter, a regular election for municipal officials is held every April. In April 2016, the election will be for the council member-at-large (mayor) and council members for Wards 3 and 4. Each candidate for the council member-at-large position must file a nominating petition signed by at least 100 but no more than 150 registered voters; the candidates for the Wards 3 and 4 positions must file a nominating petition signed by at least 50 but no more than 75 registered voters entitled to vote for the candidate. Nominating petitions for all candidates must be filed no later than January 12, 2016.

### Fiscal Impact

Short-Term Impact: Fiscal impact unknown at this time. The cost is based on the various entities who have placed an item on the ballot for any particular election.

The City's proportionate share for the April 2015 election was \$52,071.64; 19 entities had items on the ballot for this election. City of Columbia election items included filling council member positions for Wards 1, 2 and 6 as well as propositions for electric system revenue bonds, and stormwater utility charges.

### **AN ORDINANCE**

calling the Municipal Election to be held on Tuesday, April 5, 2016, to elect Council Member-at-large (Mayor) and Council Members for Wards 3 and 4 for the City of Columbia; directing notification of the election authority; describing the form of ballot, and the form of notice of election; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Pursuant to the Charter and Ordinances of the City of Columbia, Missouri, the general municipal election is hereby ordered to be held in the City of Columbia, Missouri, on Tuesday, April 5, 2016, to elect the following municipal officers:

Council Member-at-large (Mayor) Council Member, Third Ward Council Member, Fourth Ward

SECTION 2. The City Clerk is hereby authorized and directed to notify the Clerk of the County Commission of Boone County, Missouri, of the adoption of this ordinance no later than 5:00 p.m. on January 26, 2016, and to include in the notification all of the terms and provisions required by Chapter 115, RSMo. as amended.

SECTION 3. The form of the Notice of Election shall be substantially as set forth in "Exhibit A" attached hereto and made a part hereof as fully as if set forth herein verbatim. The City Clerk is directed to complete the Notice of Election by inserting the names of the candidates for each office in the order of the date their nominating petitions, sufficiently signed and attested, were filed with the Clerk.

SECTION 4. The election shall be held and conducted, and the results thereof canvassed and returned, in all respects in accordance with the laws of the State of Missouri and the Charter and Ordinances of the City of Columbia, Missouri.

SECTION 5. This ordinance shall be in full force and effect from and after its passage.
