BANNER ATTACHMENT AGREEMENT FOR THE PLACEMENT OF BANNERS BY BUSINESS LOOP COMMUNITY IMPROVEMENT DISTRICT

This BANNER ATTACHMENT AGREMENT (hereinafter "Agreement") between the Business Loop Community Improvement District (hereinafter "Business Loop CID"), and the City of Columbia, Missouri (hereinafter "City") is made and entered into on the date of the last signatory noted below (hereinafter "Effective Date"). City and Business Loop CID are each individually referred to herein as a "Party" and collectively as the "Parties."

Pursuant to Section 23-8.5 of the City of Columbia Code of Ordinances, the Parties agree as follows:

- 1. City agrees to allow Business Loop CID to attach banners to City's light standards located in public right-of-ways in the locations shown on the map which has been marked "**Exhibit A**" which is attached hereto and made a part of this Agreement.
- 2. The attachments shall be made by using brackets and fasteners approved by the City's Water and Light Department. Only non-staining brackets, fasteners, banners and attachments shall be used on or near lighting standards.
- 3. Banners shall be no longer than 30 inches by 96 inches and shall be made of vinyl fabric, treated canvas or other material as approved by the City's Water and Light Department.
- 4. City shall not be responsible for any damage done to the banners or attachments as a result of street lighting maintenance operations or for damage resulting from any other cause.
- 5. City may cancel this Agreement at any time by giving the Business Loop CID six (6) months prior written notice.
- 6. In no event shall the language of this Agreement constitute or be construed as a waiver or limitation for either Party's rights or defenses with regard to each Party's applicable sovereign, governmental, or official immunities and protections as provided by federal and state constitutions or laws.

IN WITNESS WHEREOF, the Parties hereto have executed this Agreement by their duly authorized representatives as of the date of the last signatory below.
